The purpose of this regular promulgation is to make revisions to policy and publications in order to clarify that a child's board payment will cover the cost of standard school supplies and that DCFS has discretion regarding determination of special board rates; to align procedures regarding Central Registry Name Removal Committee and notifications of severe maltreatment to Prosecuting Attorney more closely with state statute; to update the Child Protective Services Caretaker's Guide to comply with act passed during the 88th General Assembly, Regular Session 2011 as well as to create a CACD specific version of this publication.
