### **Workforce and Economic Development Impact**

### **Objectives**

- · Attract and retain skilled, disciplined and loyal workforce

### **Ensure statewide access to Veterans Treatment Courts**

### INTRODUCTION:

- Veterans treatment courts are innovative and effective for treatment of mental health conditions and substance abuse addictions – resolving criminal offenses and saving lives
  - Rand Corporation -- 31% of 1.8million veterans who served in Iraq and Afghanistan suffer from service-related mental health condition or traumatic brain injury
  - DOJ -- Veterans comprise 9.3% of incarcerated population; 70% jailed for non-violent offenses; 82% eligible for VA benefits; 18% had been homeless
  - DoD Veterans treatment courts reduce potential suicides while saving incarceration costs

### **FOCUS ON TREATMENT**

- Assess treatment, housing, job training, benefits tailored by Federal and state VA, veteran service organizations, local agencies
- · Fellow veteran mentoring key to success
- · Potential for charges reduced, dismissed; convictions expunged

### **SELECTION OPEN**

- Open to combat and non-combat experienced service members,
   Guard and reserve
- Consider service discharge and prohibiting offenses to ensure family and community safety

- · Implementing Veterans Treatment Courts statewide
  - Self-provides funds to pay for court, probation or other VTC cost
  - Tamps down jail overcrowding and emergency demands for expansions or new construction of county and state facilities

### **POTENTIAL LEGISLATION**

- Coalition's initiative to ensure post adjudicated veterans statewide
   VTC access whether achieved through legislative action or administrative orders
  - Perhaps gain experience through administrative court orders and then statutory guidance once regional efforts launched and experience gained
- Support Judicial Council effort to expand access across the state -- by circuit or combinations depending on need.

Extend resident tuition rates beyond Arkansas and eliminate local residency prerequisites for instate moves to attract and retain service members, veterans and their families

### **OVERVIEW**

 Veterans Access, Choice, and Accountability Act of 2014 (HR3230enacted) caps tuition at the resident rate while living in the State

(Sec 702) Approval of courses of education provided by public institutions of higher learning for purposes of All-Volunteer Force Educational Assistance Program and Post-9/11 Educational Assistance conditional on in-State tuition rate for veterans

### **OVERVIEW-- CONTINUED**

- Federal action eliminates the residency waiting period and gives us the opening to employ our Arkansas Higher Education system as means to engage, market and recruit veterans and families to move to Arkansas.
- Policy actions by individual Arkansas institutions reflect growing number of schools seeing the value in new and more distant market
  - Arkansas State and UALR has waived veteran residency waiting time
  - Arkansas Tech is close to acting on an even more aggressive path
  - University of Arkansas Fayetteville now assesses online undergrad and graduate degree students the resident tuition rate
- Local residency prerequisites at 2-year public institutions -- inside and outside the University of Arkansas system -- unequally assess veteran, serving Guardsmen and their families due to intrastate relocations.

#### GOING BEYOND THE FEDERAL LEGISLATION

- Eliminating detractors such as income tax burden on retired pay and residency waiting period lowers barriers to retention and migration
  - To take advantage of eliminating barriers must next actively engage, market and recruit service members, veterans and family members to remain/relocate to Arkansas
  - University of Arkansas system plus other public institutions give Arkansas are the means to "hook and reel in" service members in the 10- to 20-year career bracket
- Legislative-directed development of coordinated integrated marketing campaign will yield more effective statewide migration benefit than institutions operating unilaterally on their own policy authority

### **PROPOSE LEGISLATION**

- Direct establishment of a program to engage, market and recruit service members, veterans and their families to Arkansas using our public higher education system as a workforce weapon
  - Program might be similar to that used by Parks and Tourism and would be run by Workforce Services with ADHE and AEDC as partners
  - Connect non-resident students with Arkansas regions and employers; If Texas goes after at-risk states' businesses -- Arkansas should go after at-risk states' service members and veterans
- Enact legislation ensuring local tuition intrastate wide for service members to include Guardsmen and family members

## Arkansas Veterans Coalition 2015 Legislative Session Initiative #3

#### ANTICIPATED RESULTS

- 4-year and 2-year institutions benefit from access to increased GI
   Bill enrollment beyond their traditional markets
- Provides local business development, chambers of commerce and regional employers opportunity to tailor course work programs to meet local workforce needs funded by VA education benefits
- Outreach and job matching recruitment can spur workforce credentials matched to need while influencing migration of financially secure and disciplined former military personnel

### **OVERVIEW:**

- · Arkansas lags our neighbors in providing establishing state veteran homes
- Arkansas lacks a model and roadmap to determine future needs and their potential location
- Reduction in long term care coverage under ACA will reduce the number of private facilities available to veterans in coming years.

### PROPOSE LEGISLATION:

 Legislation directing inclusive and transparent planning and implementing a Veterans Home Roadmap carried out by the Veterans Commission

2015 Legislative Session Initiative #4

### STATE VETERANS HOMES ROADMAP CONSIDERATIONS:

- · Use VA Benefits population data and densities as #1 factor in site plans
- Anchor network on VA health care facilities Tobin, McClellan, Ozark medical centers and 12 VA community based outpatient clinics
- Grow network in the highest demand areas rather than regional dispersion
- Provide VA the long range plan in order for VA to program its matching construction funding program
- Consider all operating models and not necessarily the same model throughout to capitalize on local capabilities -- recognizing a state-run option may be the least effective and least efficient model
