<u>HB1019</u>	Nickels	TO ENACT THE BUY AMERICAN IN STATE PUBLIC WORKS ACT AND TO FOSTER THE PURCHASE AND USE OF AMERICAN-MADE METALS AND PRODUCTS IN STATE PUBLIC WORKS PROJECTS.
<u>HB1130</u>	Lampkin	TO AMEND ARKANSAS PROCUREMENT LAW; TO REGULATE THE PROCUREMENT OF PASSENGER MOTOR VEHICLES AND TRUCKS; AND TO ALLOW A STATE AGENCY TO PURCHASE PASSENGER MOTOR VEHICLES AND TRUCKS FROM A SOURCE OUTSIDE OF A STATE CONTRACT.
