<u>HJR1001</u>	Ray	A CONSTITUTIONAL AMENDMENT CONCERNING THE SALARIES OF ELECTED CONSTITUTIONAL OFFICERS OF THE EXECUTIVE DEPARTMENT, MEMBERS OF THE GENERAL ASSEMBLY, SUPREME COURT JUSTICES, COURT OF APPEALS JUDGES, AND PROSECUTING ATTORNEYS.
<u>HJR1002</u>	S. Meeks	AN AMENDMENT TO THE ARKANSAS CONSTITUTION CONCERNING THE TAXATION OF PERSONAL PROPERTY AND REAL PROPERTY IN THE STATE OF ARKANSAS.
<u>HJR1003</u>	Cavanaugh	A CONSTITUTIONAL AMENDMENT TO CREATE A PROCEDURE FOR THE RECALL OF CERTAIN ELECTED OFFICIALS.
<u>HJR1004</u>	Ray	A CONSTITUTIONAL AMENDMENT TO BE KNOWN AS THE "ARKANSAS TAXPAYER PROTECTION AMENDMENT".
<u>HJR1005</u>	Long	AN AMENDMENT TO THE ARKANSAS CONSTITUTION TO CREATE THE "ARKANSAS TAXPAYER BILL OF RIGHTS".
<u>HJR1006</u>	Lundstrum	A CONSTITUTIONAL AMENDMENT TO PROVIDE THAT LOTTERY PROCEEDS MAY BE USED TO FUND OR PROVIDE SCHOLARSHIPS AND GRANTS TO ARKANSAS CITIZENS ENROLLED IN VOCATIONAL-TECHNICAL SCHOOLS AND TECHNICAL INSTITUTES.
<u>HJR1007</u>	L. Fite	A CONSTITUTIONAL AMENDMENT TO LEVY AN EXCISE TAX ON CERTAIN TAXABLE SALES TO REIMBURSE COUNTIES FOR THE HOMESTEAD PROPERTY TAX CREDIT AND ADMINISTER THE APPLICATION OF THE HOMESTEAD PROPERTY TAX CREDIT.
<u>HJR1008</u>	D. Ferguson	AN AMENDMENT TO THE ARKANSAS CONSTITUTION TO CREATE THE PROTECT ARKANSAS HEALTHCARE AMENDMENT.
<u>HJR1009</u>	Lundstrum	AN AMENDMENT TO THE ARKANSAS CONSTITUTION PROVIDING THAT SUPREME COURT JUSTICES, COURT OF APPEALS JUDGES, CIRCUIT JUDGES, AND DISTRICT JUDGES SHALL BE ELECTED ON A PARTISAN BASIS.
<u>HJR1010</u>	Gazaway	A CONSTITUTIONAL AMENDMENT CONCERNING BOARDS AND COMMISSIONS GOVERNING STATE INSTITUTIONS.
<u>HJR1011</u>	Pilkington	AN AMENDMENT TO THE ARKANSAS CONSTITUTION CONCERNING CONSTITUTIONAL AMENDMENTS CONSIDERED BY ELECTORS AT A GENERAL ELECTION.
