SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2007-2008

Attached is the 2007-2008 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2007-2008 fiscal year. In summary, Gross General Revenue collections of approximately \$5,618.5 million increased \$144.1 million or 2.63% over the \$5,474.4 million collected in fiscal year 2006-07. Adjusted Net General Revenues available for distribution of \$4,529.2 million increased \$61.3 million or 1.4% over the \$4,467.9 million available for distribution in fiscal year 2006-07. Gross Special Revenues of \$1,691.9 million decreased \$7.5 million, or .44% less than the \$1,699.4 million collected in fiscal year 2006-07.
