**HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS**

Collections of Gross General Revenues year-to-date of approximately \$522.4 million have decreased \$10.1 million, or 1.9%, below the \$532.5 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$462.8 million decreased \$6.5 million, or 1.4%, from the \$469.3 million available for distribution in July 2018. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$3,016,615.92 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$3,016,615.92.

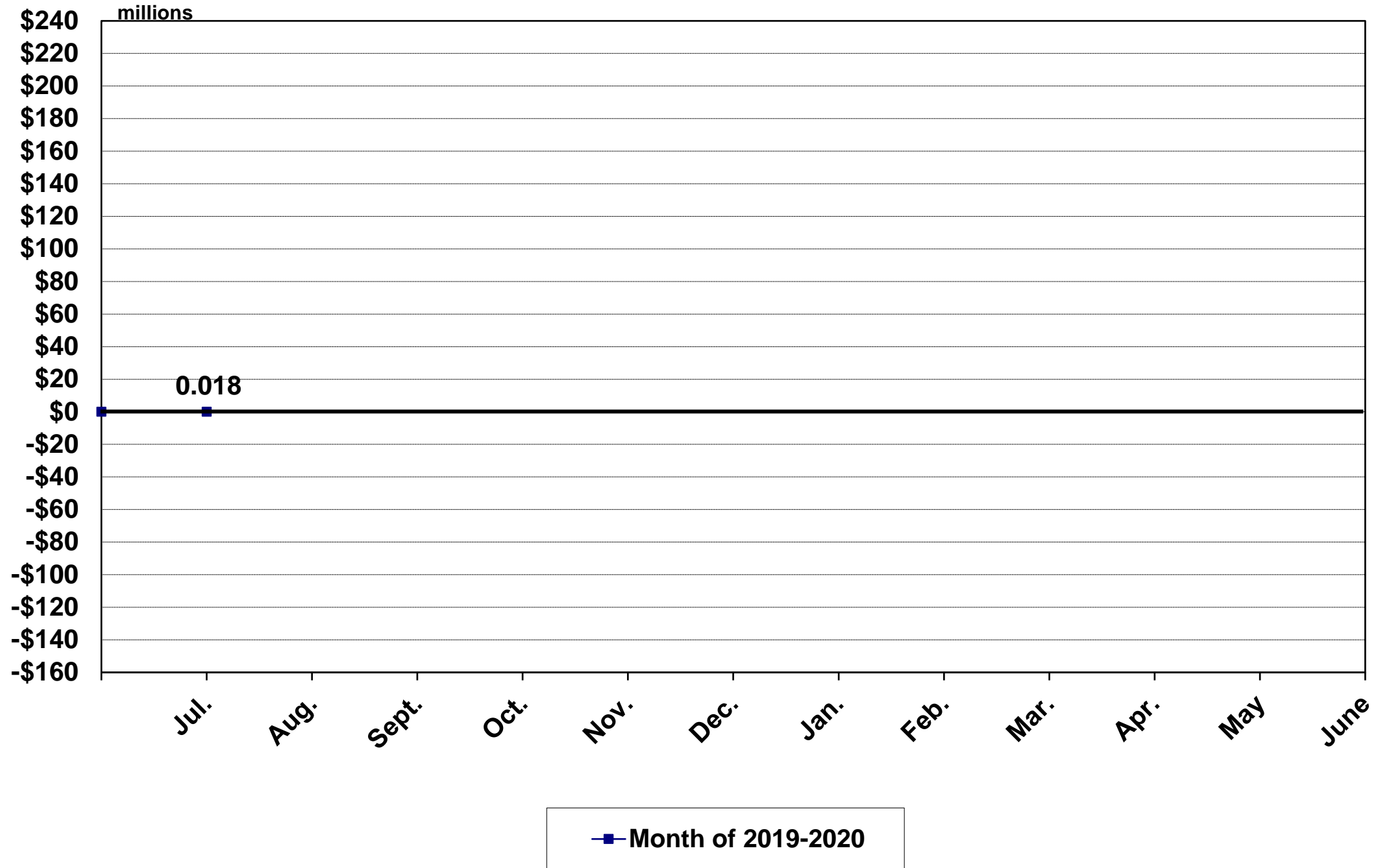
