**HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS**

Collections of Gross General Revenues year-to-date of approximately \$6,286.1 million have decreased \$209 million, or 3.2%, below the \$6,495.1 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$365.9 million decreased \$12.7 million, or 3.4%, from the \$378.6 million available for distribution in May 2019. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$3,016,615.92 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$33,182,775.12.

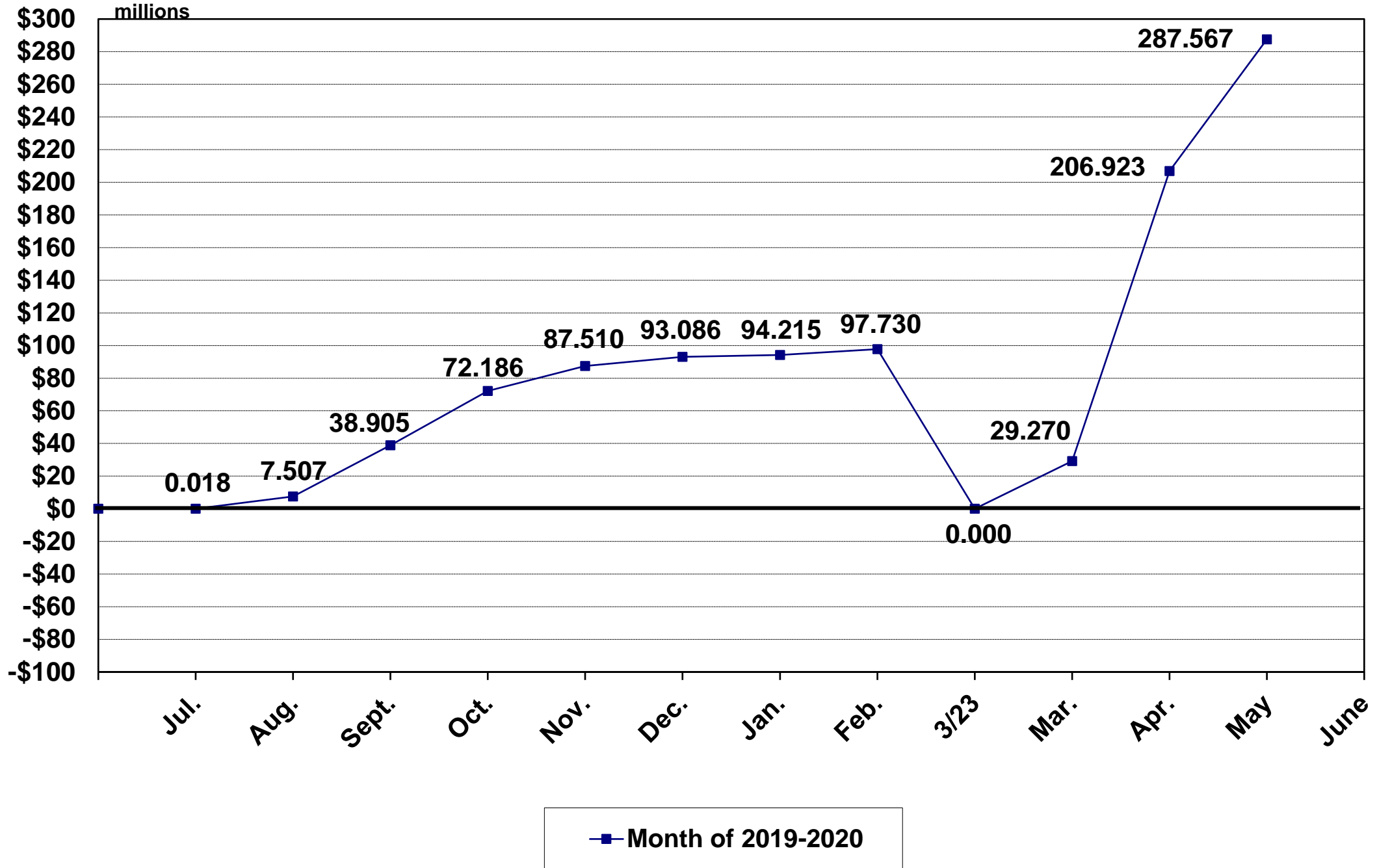
