HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$3,100.9 million have increased \$331.7 million, or 12.0%, above the \$2,769.2 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$464.0 million increased \$32.2 million, or 7.5%, from the \$431.8 million available for distribution in October 2019. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,650,012.30 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$13,250,061.50.

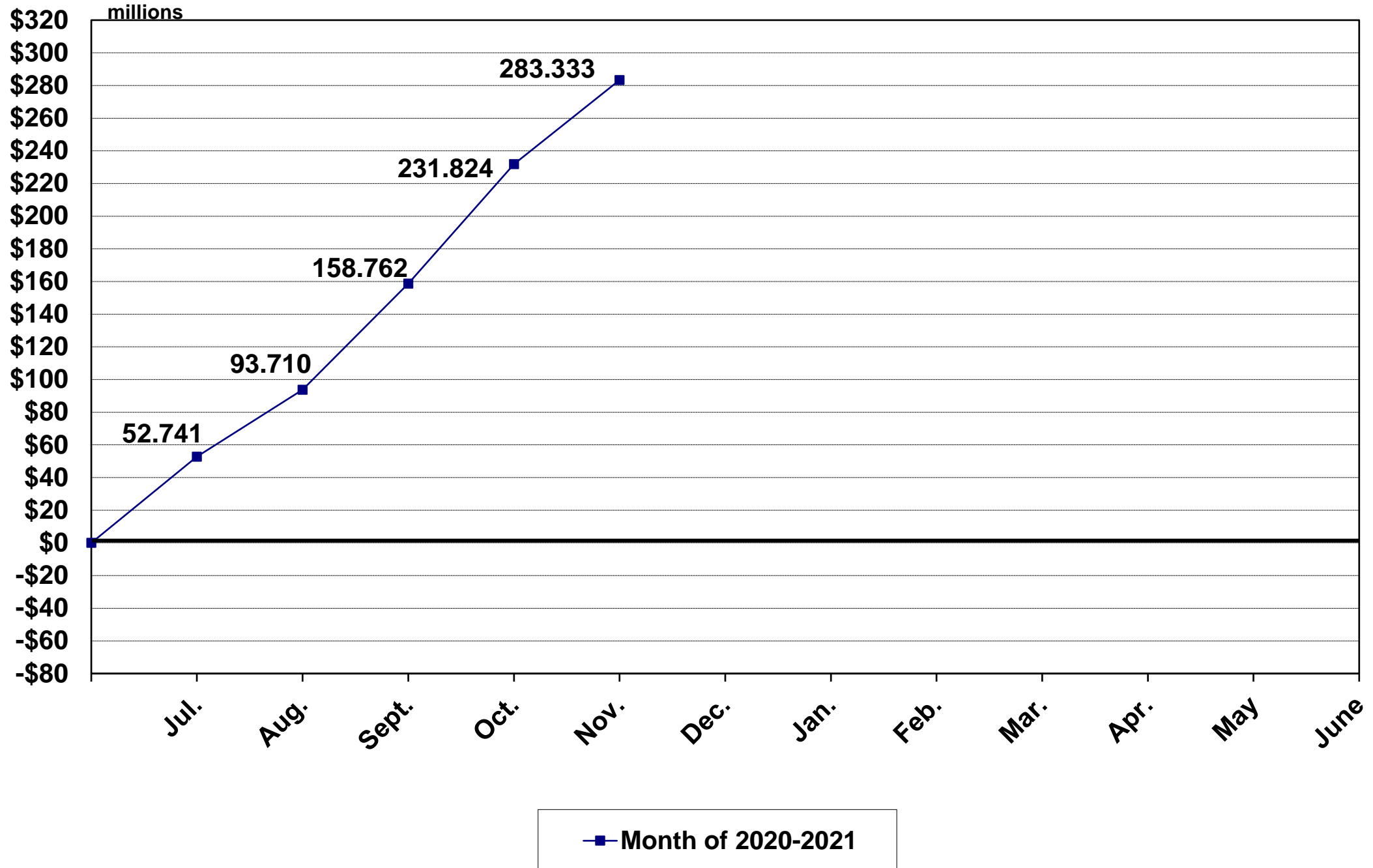
