HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$7,277.4 million have increased \$991.3 million, or 15.8%, above the \$6,286.1 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$655.17 million increased \$289.3 million, or 79.1%, from the \$365.9 million available for distribution in May 2020. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,650,012.30 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$29,150,135.30.

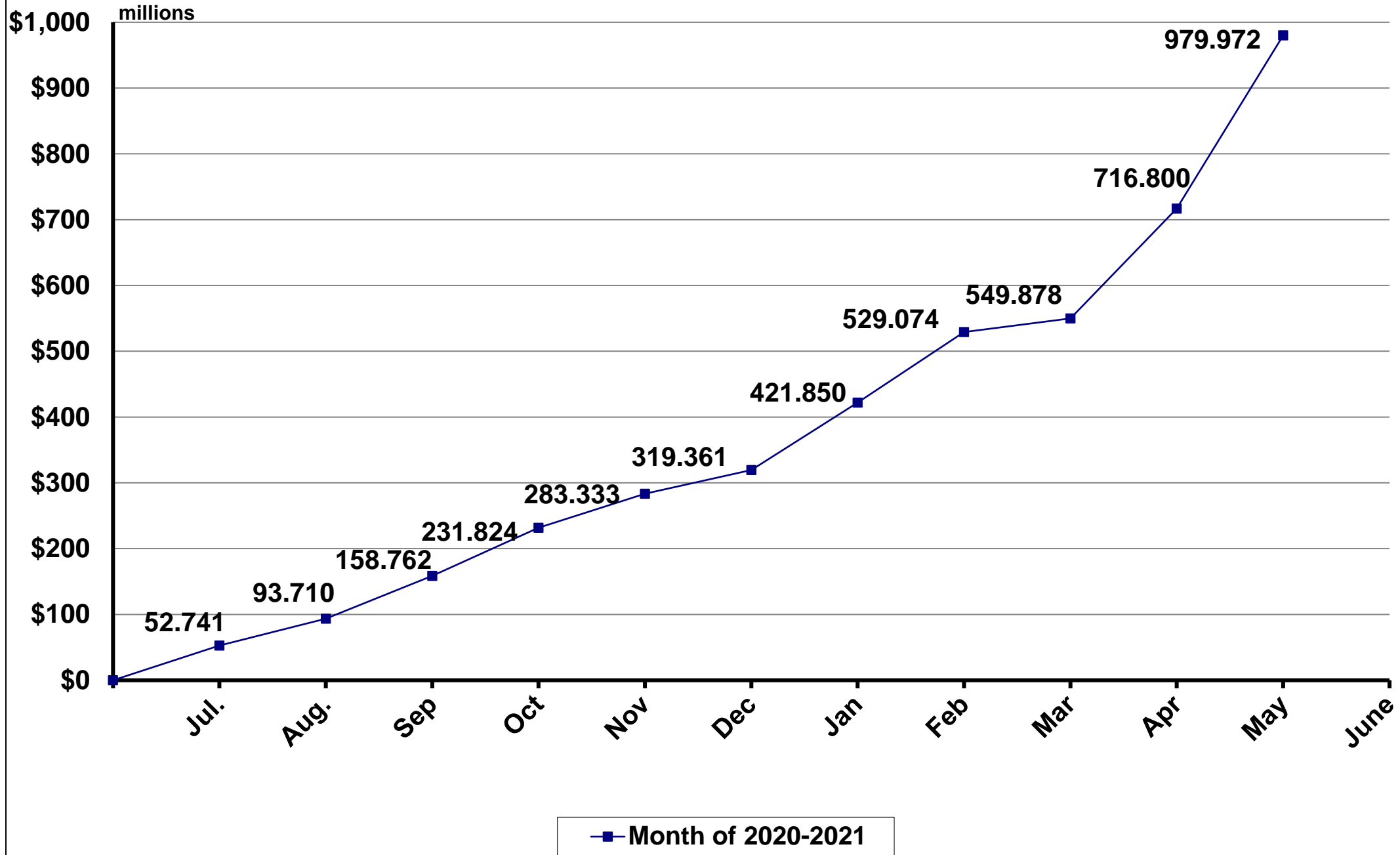
