HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

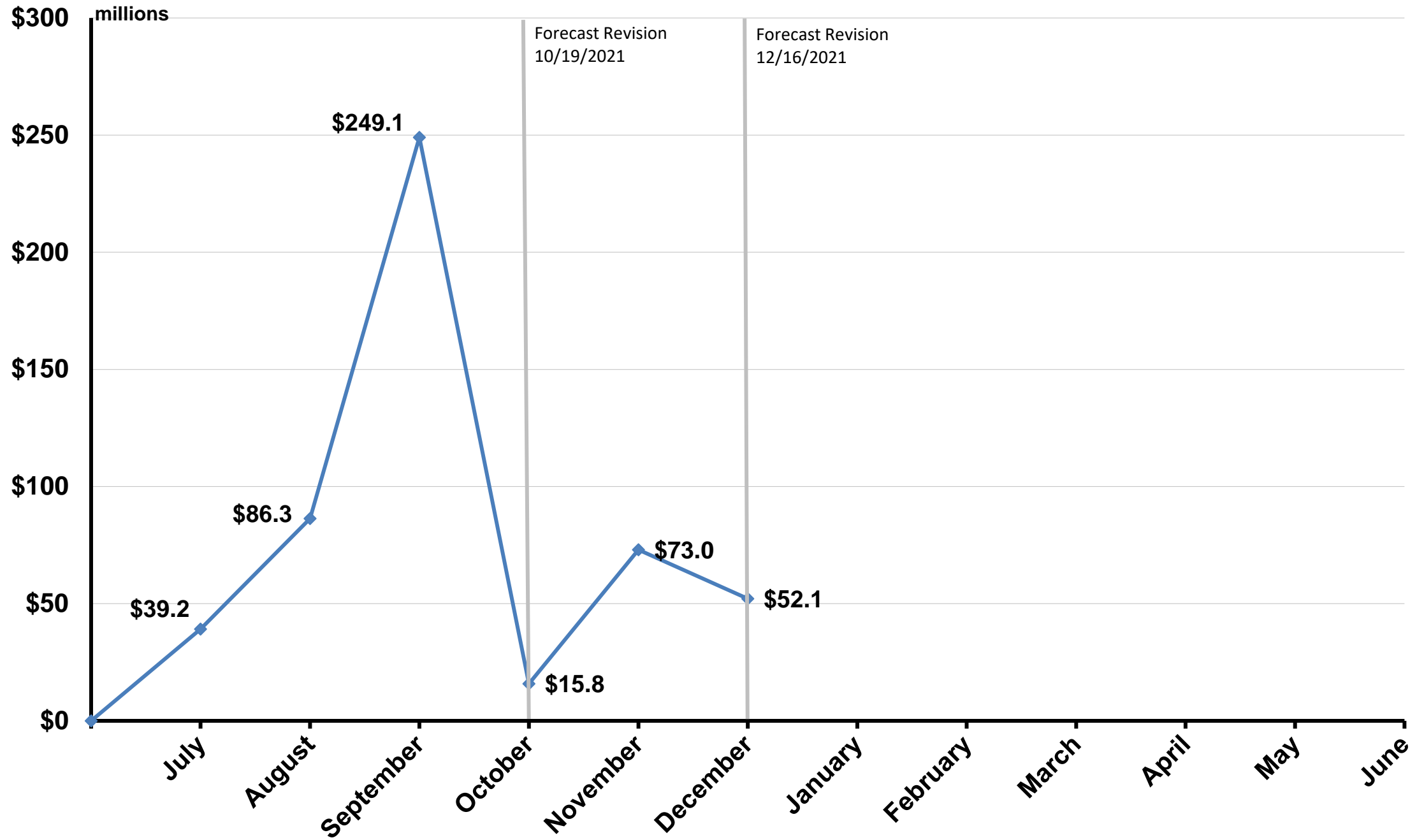

Collections of Gross General Revenues year-to-date of approximately \$3,902.8 million have increased \$195.9 million, or 5.3% above the \$3,706.8 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$646.1 million increased \$115.8 million, or 21.8% from the \$530.3 million available for distribution in December 2020.
