**SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2010-2011**

Attached is the 2010-2011 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2010-2011 fiscal year. In summary, Gross General Revenue collections of approximately \$5,686 million increased \$253.1 million or 4.7% above the \$5,432.9 million collected in fiscal year 2009-10. Adjusted Net General Revenues available for distribution of \$4,572.8 million increased \$249.7 million or 5.78% above the \$4,323.1 million available for distribution in fiscal year 2009-10. Gross Special Revenues of \$1,734.1 million increased \$60.6 million, or 3.6% more than the \$1,673.5 million collected in fiscal year 2009-10.
