**SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2014-2015**

Attached is the 2014-2015 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2014-2015 fiscal year. In summary, Gross General Revenue collections of approximately \$6,522.2 million increased \$269.4 million or 4.3% above the \$6,252.7 million collected in fiscal year 2013-14. Adjusted Net General Revenues available for distribution of \$5,250.5 million increased \$228.1 million or 4.5% over the \$5,022.4 million available for distribution in fiscal year 2013-14. Gross Special Revenues of \$1,883.7 million increased \$113.3million, or 6.4% more than the \$1,770.4 million collected in fiscal year 2013-14.
