| 18 | (C) Seven hundred twenty-three thousand one hundred |
| 19 | seventy-four (723,174) minor injuries were reported that required the |
| 20 | administration of first aid in a public school; |
| 21 | (D) Sixteen thousand nine hundred three (16,903) public |
| 22 | school staff members were administered first aid; |
| 23 | (E) Twenty-seven thousand seven hundred sixty-three |
| 24 | (27,763) public school staff members were provided blood pressure checks to |
| 25 | monitor hypertension; |
| 26 | (3) The Journal of the American Medical Association Pediatrics |
| 27 | published a study in July 2014, "Cost-Benefit Study of School Nursing |
| 28 | Services", which evaluated a school nursing services program and found that |
| 29 | every one dollar (\$1.00) invested in the program would save society two |
| 30 | dollars and twenty cents (\$2.20) after factoring in money saved by a |
| 31 | reduction in doctor and hospital visits and increases to parent and teacher |
| 32 | productivity, including a reported twenty (20) fewer minutes per day that |
| 33 | teachers spend dealing with students' health issues once a nurse is assigned |
| 34 | to their school; |
| 35 | (4) The American Academy of Pediatrics has found that: |
| 36 | (A) Survival rates of preterm infants have increased to |

- 1 more than eighty percent (80%) for infants born at twenty-six (26) weeks'
- 2 gestation and to more than ninety percent (90%) for infants born after
- 3 <u>twenty-seven (27) weeks' gestation, but some infants born before twenty-eight</u>
- 4 (28) weeks' gestation later develop moderate to severe disabilities and
- 5 learning or behavioral problems;
- 6 (B) Physical and emotional health problems rank high among
- 7 the factors that contribute to chronic absenteeism in school, which is a key
- 8 <u>risk factor for the failure to complete school;</u>
- 9 (C) Of the students seen by a school nurse for illness or
- 10 <u>injury</u>, <u>ninety-five percent (95%) were able to return to the classroom</u>, but
- 11 without a school nurse, unlicensed school personnel who are uncertain what to
- 12 <u>do medically are at risk of needlessly sending students home from school or</u>
- to the emergency department; and
- 14 (D) At least one (1) full-time professional school nurse
- 15 should be in every school to ensure the health and safety of students during
- 16 the school day;
- 17 (5) Section 6-18-1005 states that "students with special
- 18 healthcare needs, including the chronically ill, medically fragile, and
- 19 technology-dependent, and students with other health impairments shall have
- 20 individualized healthcare plans", and § 17-87-101 et seq. prohibits a
- 21 licensed practical nurse from performing that task, therefore requiring a
- 22 registered nurse to prepare the individualized healthcare plans;
- 23 (6) In 2016, the Legislative Task Force on the Best Practices
- 24 for Special Education recommended an increase in the number of school nurses
- 25 <u>within public school districts; and</u>
- 26 (7) In 2016, the Legislative Task Force on the Best Practices
- 27 <u>for Special Education also recommended that public schools have the resources</u>
- 28 necessary for delivering medical services in a public school to students with
- 29 disabilities.

- 35 determines that an appropriate school nurse-to-student ratio is essential to
- 36 effectively meet the healthcare needs of these children.

| 22 | SECTION 4. Arkansas Code § 17-87-102(9), concerning the definition of |
| 23 | "practice of licensed practical nursing", is amended to read as follows: |
| 24 | (9)(A) "Practice of licensed practical nursing" means the |
| 25 | performance for compensation of nursing practices by a licensed practical |
| 26 | nurse that are relevant to the care of the ill, injured, or infirm, or the |
| 27 | delegation of certain nursing practices to other personnel as set forth in |
| 28 | regulations established by the board, under the direction of a registered |
| 29 | nurse, an advanced practice registered nurse, a licensed physician, or a |
| 30 | licensed dentist, that do not require the substantial specialized skill, |
| 31 | judgment, and knowledge required in professional nursing: |
| 32 | (B) The board shall establish a process to ensure that a |
| 33 | licensed practical nurse employed by or contracting with a public school |
| 34 | district is under the direction of a registered nurse, an advanced practice |
| 35 | registered nurse, a licensed physician, or a licensed dentist; |
