7	SENATE RESOLUTION
8	TO PROCLAIM FEBRUARY 24, 2023, AS "SCNA2 DAY" IN
9	ARKANSAS.

13	TO PROCLAIM FEBRUARY 24, 2023, AS "SCNA2
14	DAY" IN ARKANSAS.

17	WHEREAS, SCN2A was first discovered as a cause of benign familial
18	neonatal infantile seizures (BFNIS), a syndrome that often occurs in multiple
19	family members; and
20	
21	WHEREAS, SCN2A is found on the second chromosome in the twenty-fourth
22	position; and
23	
24	WHEREAS, children with genetic variants in SCN2A can develop early
25	onset epilepsy with various levels of severity; and
26	
27	WHEREAS, SCN2A was also discovered as a cause of infantile spasms and
28	other early onset severe epilepsies of childhood, the so-called early
29	infantile epileptic encephalopathies; and
30	
31	WHEREAS, SCN2A has also been linked to Ohtahara Syndrome, Dravet
32	Syndrome, epilepsy of infancy with migrating focal seizures (EIMFS), and West
33	Syndrome among others; and
34	
35	WHEREAS, SCN2A variants are believed to be a cause of intellectual
36	disability, schizophrenia, and autism which may occur without associated



1	epilepsy; and as a variety of other medical conditions may be present in
2	people with SCN2A-related disorders, including sleep problems, cerebral
3	palsy, and movement disorders; and
4	
5	WHEREAS, SCN2A is a gene which makes a sodium channel found primarily
6	in the nerve cells that generate electricity, and SCN2A allows too much
7	sodium to enter the nerve cell and thus increases electricity, often
8	presenting with epilepsy as a main symptom; and
9	
10	WHEREAS, often, genetic testing can diagnose SCN2A mutations; and
11	
12	WHEREAS, while there is not yet a cure for SCN2A-related disorders, a
13	significant amount of research is leading to new therapies, including the
14	development of genetic approaches that aim to correct the genetic abnormality
15	rather than just treating symptoms, and new drugs that help treat SCN2A; and
16	
17	WHEREAS, increased awareness of SCN2A by citizens in the State of
18	Arkansas will allow families whose children are afflicted with SCN2A to be
19	better prepared to treat this condition and to be armed with all the
20	necessary information to take care of their children,
21	
22	NOW THEREFORE,
23	BE IT RESOLVED BY THE SENATE OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE
24	STATE OF ARKANSAS:
25	
26	THAT the Senate recognize the impact that SCN2A has on families and
27	proclaim February 24, 2023, as "SCN2A Day" in Arkansas.

29	BE IT FURTHER RESOLVED THAT upon adoption, a copy of this resolution shall be
30	provided to Mr. Brandon Beasley and Mrs. Nicole Beasley by the Secretary of
31	the Senate.
