17 THE GENERAL APPROPRIATION ACT FOR THE  
18 ORDINARY EXPENSES OF THE EXECUTIVE,  
19 JUDICIAL AND LEGISLATIVE BRANCHES FOR THE

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. APPROPRIATION - AUDITOR OF STATE DISBURSEMENTS. There is  
26 hereby appropriated, to the Auditor of State, to be payable from the  
27 Constitutional Officers Fund, for personal services and operating expenses of  
28 the Auditor of State - General Appropriations for the fiscal year ending June  
29 30, 2015, the following:

 36 appropriated, to the Arkansas House of Representatives, to be payable from

1 the Constitutional Officers Fund, for reimbursements to Representatives for  
2 interim expenses incurred as authorized by law of the Arkansas House of  
3 Representatives for the fiscal year ending June 30, 2015, the following:

15 SECTION 3. APPROPRIATION - ARKANSAS SENATE. There is hereby  
16 appropriated, to the Arkansas Senate, to be payable from the Constitutional  
17 Officers Fund, for reimbursements to Senators for interim expenses incurred  
18 as authorized by law of the Arkansas Senate for the fiscal year ending June  
19 30, 2015, the following:

31 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
33 DISBURSING OFFICER. The Auditor of State shall be disbursing officer for the  
34 funds appropriated in Section 1 herein.

35 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SENATE  
DISBURSEMENTS. The Secretary of the Senate shall be disbursing officer for  
the funds appropriated for Interim Expense Reimbursements for Senators  
herein.

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HOUSE  
DISBURSEMENTS. The Chief of Staff or his designee of the House of  
Representatives shall be disbursing officer for the funds appropriated for  
Interim Expense Reimbursements for Representatives herein.

SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HOUSE INTERIM EXPENSE DISBURSEMENTS. The appropriations authorized in Section 2 shall be used for making reimbursements for interim expenses incurred by members of the House of Representatives.

SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SENATE INTERIM EXPENSE DISBURSEMENTS. The appropriations authorized in Section 3 shall be used for making reimbursements for interim expenses incurred by members of the Senate.

SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LEGISLATIVE INSTITUTE. Members of the preceding General Assembly and the newly elected members of the House of Representatives and Senate shall be eligible to attend the biennial Institute of Legislative Procedure and shall be entitled, upon filing claim therefor, to per diem in the amount fixed by law for members of the General Assembly to receive for attendance at Legislative sessions, for each day in attending the biennial Institute of Legislative Procedure plus mileage for traveling from their place of residence to the biennial Institute of Legislative Procedure and return.

SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the

1 effectiveness of this Act on July 1, 2014 is essential to the operation of  
2 the agency for which the appropriations in this Act are provided, and that in  
3 the event of an extension of the legislative session, the delay in the  
4 effective date of this Act beyond July 1, 2014 could work irreparable harm  
5 upon the proper administration and provision of essential governmental  
6 programs. Therefore, an emergency is hereby declared to exist and this Act  
7 being necessary for the immediate preservation of the public peace, health  
8 and safety shall be in full force and effect from and after July 1, 2014.
