19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code §§ 5-51-401 through 5-51-404 are repealed.

22 ~~5-51-401. Definition.~~

23 ~~As used in this subchapter, unless the context otherwise requires,~~

24 ~~"Communist Party" means:~~

25 ~~(1) The Communist Party of the United States;~~

26 ~~(2) The Communist Political Association;~~

27 ~~(3) The Communist Party of any state of the United States, of~~  
28 ~~any foreign state, or any political or geographical subdivision of any~~  
29 ~~foreign state;~~

30 ~~(4) Any section, subsidiary, branch, affiliate, or subdivision~~  
31 ~~of any such association or party; or~~

32 ~~(5) Any organization which advocates or teaches the overthrow by~~

1           ~~The General Assembly of the State of Arkansas finds and determines~~  
2 ~~that:~~

3                   ~~(1) The Communist Party advocates, teaches, and encourages the~~  
4 ~~overthrow of the governments of the United States and of the State of~~  
5 ~~Arkansas by force and violence, the same being contrary to the Constitutions~~  
6 ~~of the United States and of the State of Arkansas; and~~

7                   ~~(2) The existence of the Communist Party and membership in such~~  
8 ~~party is an immediate and constant threat to the peace, safety, and security~~  
9 ~~of the State of Arkansas and of the people thereof.~~

11           ~~5-51-403. Prohibition on party operation and membership.~~

12           ~~(a) It shall be unlawful for the Communist Party to operate in the~~  
13 ~~State of Arkansas, and it shall be unlawful for any person in the State of~~  
14 ~~Arkansas to knowingly be a member of or belong to the Communist Party.~~  
15 ~~Membership in the Communist Party shall be prima facie evidence that a person~~  
16 ~~advocates, teaches, and encourages the forceful and violent overthrow of the~~  
17 ~~government of the State of Arkansas.~~

18           ~~(b) Any person violating the provisions of this section shall, upon~~  
19 ~~conviction, be imprisoned for a period of not less than one (1) year nor more~~  
20 ~~than twenty one (21) years or shall be fined in an amount of not less than~~  
21 ~~one thousand dollars (\$1,000) nor more than five thousand dollars (\$5,000),~~  
22 ~~or be both so fined and imprisoned.~~
