

"AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES OF THE ARKANSAS LIVESTOCK AND POULTRY COMMISSION FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby established for the Arkansas Livestock and Poultry Commission - General Operations for the 1987-89 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act, or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

SECTION 2. EXTRA HELP - GENERAL OPERATIONS. There is hereby authorized, for the Arkansas Livestock and Poultry Commission for the 1987-89 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: Forty-one (41) temporary or part-time employees, when needed in the Commission's livestock inspection and disease control, laboratory services, and administrative programs, at rates not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, for the appropriate classification.

There is hereby appropriated, to the Arkansas Livestock and Poultry Commission - General Operations, to be payable from the Livestock and Poultry Fund Account, for personal services and operating expenses of the Arkansas Livestock and Poultry Commission - General Operations for the biennial period ending June 30, 1989, the following:

There is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be payable from the Livestock and Poultry Commission Disease and Pest Control Fund, for operating expenses of the Arkansas Livestock and Poultry Commission - Brucellosis Control and Eradication Program for the biennial period ending June 30, 1989, the following:

SECTION 14. A Junior Livestock Show is authorized for each of the five (5) Livestock Show Districts of the State. Any organization desiring to establish a District Junior Livestock Show shall make application and submit proposed organizational and operational plans therefor to the Arkansas Livestock and Poultry Commission. The Livestock and Poultry Commission is authorized to approve only one District Junior Livestock Show in each of the five (5) Livestock Show Districts. Only those District Junior Livestock Shows approved by the Livestock and Poultry Commission shall be eligible to participate in the funds appropriated in Item (04) of Section 12 hereof. Each such approved show shall be entitled to receive Four Thousand Dollars (\$4,000) from the funds appropriated in Item (04), of Section 12 hereof, to be used exclusively for premiums for livestock and poultry entries of Arkansas 4H and FFA members.

SECTION 15. DISBURSING PROCEDURES. The appropriations provided herein by Items (01), (02), and (03) of Section 12 shall be distributed to the State and to respective District and County Livestock Show Associations as provided by Act 317 of 1973, or subsequent laws as may be enacted for the distribution of premium monies.

Funds appropriated in Item (05) of Section 12 shall be disbursed by the disbursing officer of the Livestock and Poultry Commission on claims certified by the Director of Vocational Agriculture of the Department of Education. The funds appropriated in Item No. (05) of Section 12 hereof shall be used exclusively for reimbursing members of high school 4H Clubs, high school FFA Clubs, and members of the Arkansas Razorback State High School Rodeo Association, and Miss Arkansas Rodeo for representing the State of Arkansas at national conferences and events outside the State. Reimbursement of expenses from funds appropriated in Item No. (05) of Section 12 shall be limited to actual transportation costs plus not to exceed twenty-five dollars (\$25.00) per day for meals and lodging. Only those claims for reimbursement certified by the Director of Vocational Agriculture of the State Department of Education shall be allowed.

SECTION 16. OVERTIME COMPENSATION. The Livestock and Poultry - Egg and

Poultry Grading Program is hereby authorized to pay ordinary, customary and necessary overtime compensation in accordance with rules and regulations promulgated by the Chief Fiscal Officer of the State to those employees, including egg and poultry grader supervisors engaged in the inspection and grading of eggs and poultry products.

SECTION 17. RESTRICTION. The Appropriation authorized for the Buffalo Gnat Control Program in Item (07) Section 3, of this Act, shall be expended only for the control of buffalo gnats in the Arkansas counties of Miller, LaFayette, Little River and parts of Hempstead.

SECTION 18. CARRY FORWARD. Any unexpended balance of appropriation provided in Section 13 of this Act, which remains at the close of the fiscal year ending June 30, 1988, shall be carried forward and made available for the same purpose for the fiscal year ending June 30 1989.

SECTION 19. APPROPRIATIONS - POULTRY INDEMNITIES. There is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be payable from the cash funds of the Arkansas Livestock and Poultry Commission made available by grants and donations from non-state sources, for Poultry Indemnities, of the Arkansas Livestock and Poultry Commission - Poultry Indemnities for the biennial period ending June 30, 1989, the following:

SECTION 20. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 21. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 22. CONTRACT RESTRICTIONS. The agency, board, commission, department or institution to whom funds are appropriated by this Act shall not enter into any contract for any professional or consultant services which shall extend for more than twenty (20) actual working days or the total compensation exceeds five thousand dollars (\$5,000) during any one fiscal year without first seeking the advice of the Arkansas Legislative Council. Provided further, that all contracts for professional or consultant services shall be submitted monthly to the Chief Fiscal Officer of the State for reporting to the Legislative Council.

SECTION 23. EMERGENCY CLAUSE. It is hereby found and determined by the

Seventy-Sixth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1987 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1987 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1987.
