"AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES OF THE UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; AND FOR OTHER PURPOSES."

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the University of Arkansas for Medical Sciences for the 1987-89 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act, and the Higher Education Employee Classification and Compensation Act, or their successors, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act and said Higher Education Employee Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

SECTION 2. EXTRA HELP. There is hereby authorized, for the University of Arkansas for Medical Sciences for the 1987-89 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: Seven hundred fifty (750), when needed, at rates of pay not to exceed the rate of pay for comparable positions authorized by this Act, by the Uniform Classification and Compensation Act, and by the Higher Education Employee Classification and Compensation Act, or their successors, and all laws amendatory thereto.

SECTION 3. EXTRA HELP - NATIONAL CENTER FOR TOXICOLOGICAL RESEARCH. There is hereby authorized, for the University of Arkansas for Medical Sciences - National Center for Toxicological Research for the 1987-89 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: Twenty-five (25), when needed, at rates of pay not to exceed the rate of pay for comparable positions authorized by this Act, by the Uniform Classification and Compensation Act, and by the Higher Education Employee Classification and Compensation Act, or their successors, and all laws amendatory thereto.

SECTION 4. EXTRA HELP - UNIVERSITY HOSPITAL PRN POOL. There is hereby authorized, for the University of Arkansas for Medical Sciences, the following number of part-time or temporary positions, to be known as "PRN Extra Help", payable from funds appropriated herein, for the purpose of employing RN's and LPN's in a Nursing PRN Pool: one hundred fifty (150), when needed, at rates of pay not to exceed the rate of pay for comparable positions authorized by this Act.

SECTION 5. APPROPRIATIONS - GENERAL REVENUE. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the University of Arkansas Medical Center Fund, for personal services and operating expenses of the University of Arkansas for Medical Sciences for the biennial period ending June 30, 1989, the following:

SECTION 7. ARKANSAS CHILDREN'S HOSPITAL. Thirty-three and one-third percent ( $33-1 / 3 \%$ ) in each fiscal year of the biennial period ending June 30, 1989, of the amounts made available to fund the appropriation in Item (05) of Section 5 of this Act shall be distributed to the Arkansas Children's Hospital.

SECTION 8. SPECIAL ALLOWANCES. The Board of Trustees may make special allowances available, in such amounts as the Board may determine or justify equitable in view of the exacting duties which are involved, as a part of the salaries of the physicians and dentists employed by the College of Medicine of the University of Arkansas for Medical Sciences, for their additional duties in attending patients through auspices of the University of Arkansas for Medical Sciences, these allowances to be paid by the Board of Trustees from auxiliary income of the University of Arkansas for Medical Sciences from receipts of professional income in the care of patients. Provided that any such allowance shall not exceed, for any employee, an amount equal to one and one-half (1-1/2) times that portion of the salary authorized by the General Assembly to be paid from the University of Arkansas Medical Center Fund.

SECTION 9. SPECIAL ALLOWANCES. The Board of Trustees of the University of Arkansas is hereby authorized to make available to the President of the University of Arkansas special allowances in such amounts as the Board may determine to be justified at the University of Arkansas for Medical Sciences, for the use of the Chancellor and his deans, representatives, department heads, and directors at the University of Arkansas for Medical Sciences in recruitments of faculty and staff members. Upon approval by the President and the Board of Trustees, such funds shall be administered by the Chancellor, who shall assure that the total amount expended for such purposes does not exceed fifty thousand dollars ( $\$ 50,000$ ) each fiscal year or so much thereof as may be authorized by the Board of Trustees. The funds authorized by this Section shall come from a source other than state tax dollars appropriated by the General Assembly or charges made to students for tuition, fees, room and board, or other purposes. Each year the Chancellor shall furnish to the President of the University of Arkansas, the Board of Trustees, and the Arkansas Legislative Joint Auditing Committee a report showing for each expenditure that date, the amount, the names of persons to whom the expenditure was
made, and the purpose for which the expenditure was made.
SECTION 10. SPECIAL LANGUAGE AND RESTRICTIONS - AREA HEALTH EDUCATION CENTERS. The positions authorized under the heading "TWELVE-MONTH-AHEC" of Section 1 of this Act shall be utilized exclusively for the implementation and operation of the Area Health Education Centers (AHEC) to be administered by the Chancellor of the University of Arkansas for Medical Sciences. The Chancellor at the University of Arkansas for Medical Sciences shall make periodic progress reports of AHEC programs to the Governor, the Legislative Council, and other interested interim committees of the General Assembly regarding the achievements, the expansion of the aforementioned programs, and amounts expended for the Area Health Education Centers.

SECTION 11. CONTRACT RESTRICTIONS (PHYSICIAN TEACHERS AND TEACHERS IN OTHER HEALTH RELATED PROFESSIONS) AREA HEALTH EDUCATION CENTERS. Funds appropriated by this Act may be utilized for the purpose of contracting with physician-teachers and teachers in other health related professions residing only at sites located away from the University of Arkansas for Medical Sciences. Such funds are to be paid only for the purpose of teaching residents and students assigned to Area Health Education Centers. Contracts entered into with physician-teachers, teachers in other health related fields and their associates shall require the prior approval of the Chief Fiscal Officer of the State only and be reported quarterly to the Legislative Council.

SECTION 12. SPECIAL PROVISIONS FOR UNCLASSIFIED PATIENT CARE PERSONNEL. All unclassified positions employed to provide patient care at the University of Arkansas for Medical Sciences are eligible for overtime at the rate of one and one-half times their regular hourly rate. In addition to overtime, those unclassified patient care employees regularly scheduled to work the second/ third shift will be eligible to receive up to fourteen (14) percent of the hourly rate paid as a shift differential. Employees required to be available for duty on nights, weekends and holidays will be eligible to receive standby pay equivalent of up to four hours of work per shift. Employees required to work in specialty areas will be eligible to receive up to ten (10) percent of the hourly rate paid as a specialty differential while working in such areas. When overtime, shift differentials, standby pay and/or specialty differential are provided to employees as herein described, the total regular, overtime, shift differential, standby pay and specialty differential may exceed the line item maximum salaries for those positions as included in this Act. The positions of Patient Care Administrator, Associate Administrator, and Assistant Administrator of Patient Care as authorized in Section 1 of this Act shall be excluded from coverage in this Section.

SECTION 13. DAY CARE. Of the funds appropriated in Section 5 of this Act, $\$ 250,000$ each year of the biennium may be allocated as the State's portion of the operating cost of a Child Care Facility for use by personnel of the University of Arkansas for Medical Sciences and the Department of Human Services - Mental Health Division, with nursing personnel given first priority. Personnel using this facility will be charged a daily rate as determined by the University of Arkansas for Medical Sciences.

SECTION 14. HOUSING ALLOWANCE. The Board of Trustees of the University of Arkansas may approve a housing allowance up to $\$ 650$ per month for the Chancellor of the University of Arkansas for Medical Sciences. Such allowance shall be in lieu of any state-owned housing provided for the Chancellor. Provided, in the event that the current Chancellor's home, located in Little

Rock, Arkansas is sold, the proceeds of such sale shall be invested and the proceeds of the investment shall be used to defray the total cost of the housing allowance of $\$ 650$ per month or so much as the investment proceeds will provide, whichever is the lesser.

SECTION 15. CARRY FORWARD. Any unexpended balance of the appropriations and funds provided by this Act which remains at the close of the fiscal year ending June 30, 1988, up to a maximum of $\$ 1,500,000$, shall be carried forward and made available for the same purpose for the fiscal year ending June 30, 1989.

SECTION 16. PERSONNEL RESTRICTIONS. The number of persons employed in a position under the heading "UNIVERSITY HOSPITAL - PATIENT CARE", either as a Registered Nurse II, Registered Nurse I, LPN II, or LPN I, as authorized by this Act, shall not exceed an aggregate amount of five hundred forty-nine (549) during any one (1) payroll period.

SECTION 17. STIPENDS. The University of Arkansas for Medical Sciences is hereby authorized to pay stipends to students engaged in post-graduate clinical training in accredited programs of the University of Arkansas for Medical Sciences, from "Regular Salaries" or "Maintenance and General Operation", as follows:

SECTION 18. ADMISSION POLICY. The University of Arkansas for Medical Sciences shall admit one hundred fifty (150) freshman students in each year of the 1987-89 biennium into the College of Medicine, and shall submit a 1989-91 biennial budget request to the State Board of Higher Education and the Arkansas Legislative Council which includes provisions for an admission policy of one hundred sixty (160) freshman students in the College of Medicine for each year of the 1989-91 biennium. Provided, that no funds shall be expended to fund the positions of Chancellor, Dean of Medicine and any academic position until the Chancellor and Dean of Medicine certify to the Arkansas Legislative Council that the provision of this Section relating to the 1987-89 biennium requirement for one hundred fifty (150) freshman student admissions has been implemented.

SECTION 19. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditure Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 20. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or
summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 21. CONTRACT RESTRICTIONS. The agency, board, commission, department or institution to whom funds are appropriated by this Act shall not enter into any contract for any professional or consultant services which shall extend for more than twenty (20) actual working days or the total compensation exceeds five thousand dollars (\$5,000) during any one fiscal year without first seeking the advice of the Arkansas Legislative Council. Provided further, that all contracts for professional or consultant services shall be submitted monthly to the Chief Fiscal Officer of the State for reporting to the Legislative Council.

SECTION 22. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1987 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1987 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1987.
