Act 26 HB1017

"AN ACT TO AMEND SECTIONS 6 AND 7 OF ACT 608 OF 1987 AND TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES OF THE OFFICE OF THE SECRETARY OF STATE AND TO AMEND SECTION 3 OF ACT 244 OF 1987 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Items (01) and (03) of Section 6 of Act 608 of 1987 are hereby amended to read as follows:

- "(01) REGULAR SALARIES \$802,538 \$866,815 (03) PERSONAL SERV MATCHING 201,748 217,755"
- SECTION 2. Items (01) and (03) of Section 7 of Act 608 of 1987 are hereby amended to read as follows:
 - "(01) REGULAR SALARIES \$1,181,344 \$1,208,210 (03) PERSONAL SERV MATCHING 245,738 302,801"

SECTION 3. REGULAR SALARIES. There is hereby established for the Secretary of State, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act, or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, meeting in Third Extraordinary Session, that additional responsibilities have been placed upon the Office of the Secretary of State without the additional financial resources needed in order to support such responsibilities, and that the provisions of this Act will provide such financial resources so that essential governmental services can be provided to the citizens of this State. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after its passage and approval.
