Ark. Code Ann. §17-92-308(a) is hereby amended to read as 16 follows: "(a) After due notice and hearing, the board may refuse to register any 17 18 physical therapist or physical therapist assistant applicant and may revoke the registration of any registered person who: 20 (1) Is habitually drunk or who is addicted to the use of narcotic 21 drugs; 22 (2) Has been convicted of violating any state or federal narcotic 23 law; Is, in the judgment of the board, guilty of immoral or 2.4 (3) 25 unprofessional conduct; (4) Has been convicted of any crime involving moral turpitude; 26 Is guilty, in the judgment of the board, of gross negligence 2.7 28 in his practice; (6) Has obtained, or attempted to obtain, registration by fraud 29 30 or material misrepresentation; 31 (7) Has been declared insane by a court of competent jurisdiction 32 and has not thereafter been lawfully declared sane; (8) Has treated, or undertaken to treat, ailments of human beings 33 34 otherwise than by physical therapy, and as authorized by this chapter, or has 35 undertaken to practice independent of the referral of a person licensed to 36 practice medicine and surgery without limitation; orHB 1770

| 17 | are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code    |
| 18 | Revision Commission shall incorporate the same in the Code.                    |

| 20 | SECTION 3. If any provision of this act or the application thereof to          |
| 21 | any person or circumstance is held invalid, such invalidity shall not affect   |
| 22 | other provisions or applications of the act which can be given effect without  |
| 23 | the invalid provision or application, and to this end the provisions of this   |
| 24 | act are declared to be severable.  |
