For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF HUMAN SERVICES -
10 DIVISION OF STATE SERVICES FOR THE BLIND FOR THE BIENNIAL
11 PERIOD ENDING JUNE 30, 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
14

15 SECTION 1. REGULAR SALARIES. There is hereby established for the
16 Department of Human Services - Division of State Services for the Blind for
17 the 1991-93 biennium, the following maximum number of regular employees whose
18 salaries shall be governed by the provisions of the Uniform Classification and
19 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
20 laws amendatory thereto. Provided, however, that any position to which a
21 specific maximum annual salary is set out herein in dollars, shall be exempt
22 from the provisions of said Uniform Classification and Compensation Act. All
23 persons occupying positions authorized herein are hereby governed by the
24 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
25 Code §21-5-101), or its successor.

21 SECTION 2. EXTRA HELP. There is hereby authorized, for the
 22 Department of Human Services - Division of State Services for the Blind for
 23 the 1991-93 biennium, the following maximum number of part-time or temporary
 24 employees, to be known as "Extra Help", payable from funds appropriated herein
 25 for such purposes: fourteen (14) temporary or part-time employees, when
 26 needed, at rates of pay not to exceed those provided in the Uniform
 27 Classification and Compensation Act, or its successor, or this act for the
 28 appropriate classification.

29

30 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the
 31 Department of Human Services - Division of State Services for the Blind, to be
 32 payable from the Department of Human Services Paying Account as designated by
 33 the Chief Fiscal Officer of the State, for personal services and operating
 34 expenses of the Department of Human Services - Division of State Services for
 35 the Blind for the biennial period ending June 30, 1993, the following:

16 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

17 authorized by this Act shall be limited to the appropriation for such agency

18 and funds made available by law for the support of such appropriations; and

19 the restrictions of the State Purchasing Law, the General Accounting and

20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

21 Procedures and Restrictions Act, or their successors, and other fiscal control

22 laws of this State, where applicable, and regulations promulgated by the

23 Department of Finance and Administration, as authorized by law, shall be

24 strictly complied with in disbursement of said funds.

25

26 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General

27 Assembly that any funds disbursed under the authority of the appropriations

28 contained in this Act shall be in compliance with the stated reasons for which

29 this Act was adopted, as evidenced by the Agency Requests, Executive

30 Recommendations and Legislative Recommendations contained in the budget

31 manuals prepared by the Department of Finance and Administration, letters, or

32 summarized oral testimony in the official minutes of the Arkansas Legislative

33 Council or Joint Budget Committee which relate to its passage and adoption.

34

35 SECTION 6. CODE. All provisions of this Act of a general and permanent

1 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
2 Code Revision Commission shall incorporate the same in the Code.

4 SECTION 7. SEVERABILITY. If any provision of this Act or the
5 application thereof to any person or circumstance is held invalid, such
6 invalidity shall not affect other provisions or applications of the Act which
7 can be given effect without the invalid provision or application, and to this
8 end the provisions of this Act are declared to be severable.

9

10 SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict
11 with this Act are hereby repealed.

12

13 SECTION 9. HEALTH PREMIUMS. The Department of Human Services -
14 Division of State Services for the Blind shall not, during the 1992-93 fiscal
15 year, spend more for health insurance per employee than the amount being
16 contributed to the State Employees Health Insurance Program.

17

18 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the
19 Seventy-Eighth General Assembly, that the Constitution of the State of
20 Arkansas prohibits the appropriation of funds for more than a two (2) year
21 period; that the effectiveness of this Act on July 1, 1991 is essential to the
22 operation of the agency for which the appropriations in this Act are provided,
23 and that in the event of an extension of the Regular Session, the delay in the
24 effective date of this Act beyond July 1, 1991 could work irreparable harm
25 upon the proper administration and provision of essential governmental
26 programs. Therefore, an emergency is hereby declared to exist and this Act
27 being necessary for the immediate preservation of the public peace, health and
28 safety shall be in full force and effect from and after July 1, 1991.
