A BILL ACT 1204 OF 1991
SENATE BILL 654

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR CAPITAL EQUIPMENT AND
9 COSTS INCURRED AT VARIOUS ARMORIES AND FACILITIES FOR THE
10 STATE MILITARY DEPARTMENT FOR THE BIENNIAL PERIOD ENDING
11 JUNE 30, 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14
15 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the State
16 Military Department, to be payable from the General Improvement Fund or its
17 successor fund or fund accounts, the following:

18 (A) For the purchase of capital equipment, the sum of\$35,000.

19
20 (B) For replacement costs and equipment of the National Guard Armory at
21 Benton, the sum of\$319,000.

23 (C) For construction and equipping of an Administration Office addition
24 at Camp Robinson, the sum of\$1,661,000.

25
26 (D) For costs associated with replacing and equipping the Camp Robinson
27 National Guard Armory, the sum of\$1,109,719.

28
29 (E) For constructing and equipping an aviation addition to the Camp
30 Robinson National Guard Armory, the sum of\$573,000.

31
32 (F) For termite and pest control contracts at various Arkansas
33 facilities, the sum of\$325,000.

35 (G) For design costs of a facility to replace the National Guard Armory
36 at Mountain Home, the sum of\$14,000.

(H) For design costs of a facility to replace the National Guard Armory at Morrilton, the sum of \$14,000.

SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the State Military Department, to be payable from the federal funds as designated by the Chief Fiscal Officer of the State, the following:

(A) For costs associated with replacing and equipping the National Guard Armory at Benton, the sum of \$947,000.

(B) For costs associated with replacing and equipping the Camp Robinson National Guard Armory, the sum of \$3,329,156.

(C) For constructing and equipping an aviation addition to the Camp Robinson National Guard Armory, the sum of \$1,487,360.

(D) For design costs of a facility to replace the National Guard Armory at Mountain Home, the sum of \$40,000.

(E) For design costs of a facility to replace the National Guard Armory at Morrilton, the sum of \$40,000.

SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this Act.

(B) The restrictions of any applicable provisions of the State

1 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
2 Revenue Stabilization Law and any other applicable fiscal control laws of this
3 State and regulations promulgated by the Department of Finance and
4 Administration, as authorized by law, shall be strictly complied with in
5 disbursement of any funds provided by this Act unless specifically provided
6 otherwise by law.

8 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
9 Assembly that any funds disbursed under the authority of the appropriations
10 contained in this Act shall be in compliance with the stated reasons for which
11 this Act was adopted, as evidenced by the Agency Requests, Executive
12 Recommendations and Legislative Recommendations contained in the budget
13 manuals prepared by the Department of Finance and Administration, letters, or
14 summarized oral testimony in the official minutes of the Arkansas Legislative
15 Council or Joint Budget Committee which relate to its passage and adoption.

17 SECTION 5. CODE. All provisions of this Act of a general and permanent
18 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
19 Code Revision Commission shall incorporate the same in the Code.

21 SECTION 6. SEVERABILITY. If any provision of this Act or the
22 application thereof to any person or circumstance is held invalid, such
23 invalidity shall not affect other provisions or applications of the Act which
24 can be given effect without the invalid provision or application, and to this
25 end the provisions of this Act are declared to be severable.

27 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
28 with this Act are hereby repealed.

29

30 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
31 Seventy-Eighth General Assembly, that the Constitution of the State of
32 Arkansas prohibits the appropriation of funds for more than a two (2) year
33 period; that the effectiveness of this Act on July 1, 1991 is essential to the
34 operation of the agency for which the appropriations in this Act are provided,
35 and that in the event of an extension of the Regular Session, the delay in the

1 effective date of this Act beyond July 1, 1991 could work irreparable harm
2 upon the proper administration and provision of essential governmental
3 programs. Therefore, an emergency is hereby declared to exist and this Act
4 being necessary for the immediate preservation of the public peace, health and
5 safety shall be in full force and effect from and after July 1, 1991.
