8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND

9 OPERATING EXPENSES FOR THE ARKANSAS HOUSE OF

10 REPRESENTATIVES FOR THE BIENNIAL PERIOD ENDING JUNE 30,

11 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14

15 SECTION 1. REGULAR SALARIES-STAFF. There is hereby established for the

16 Arkansas House of Representatives for the 1991-93 biennium, the following

17 maximum number of regular employees whose salaries shall be governed by the

18 provisions of the Uniform Classification and Compensation Act (Arkansas Code

19 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.

20 Provided, however, that any position to which a specific maximum annual salary

21 is set out herein in dollars, shall be exempt from the provisions of said

22 Uniform Classification and Compensation Act. All persons occupying positions

23 authorized herein are hereby governed by the provisions of the Regular

24 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its

25 successor.

- 9 number of part-time or temporary employees, to be known as "Extra Help",
- 10 payable from funds appropriated in Section 12 herein for such purposes: seven
- 11 (7) temporary or part-time employees, when needed, at rates of pay not to
- 12 exceed those provided in the Uniform Classification and Compensation Act, for
- 13 the appropriate classification.

- SECTION 3. APPROPRIATIONS-STAFF. There is hereby appropriated, to the
- 16 Arkansas House of Representatives, to be payable from the State Central
- 17 Services Fund, for personal services and operating expenses of the Arkansas
- 18 House of Representatives for the biennial period ending June 30, 1993, the
- 19 following:

- 29 SECTION 4. If the Speaker of the House and the Coordinator of House
- 30 Legislative Services determine that any item or portion thereof appropriated
- 31 herein for a specific purpose is not needed for such purpose, they may certify
- 32 such fact to the State Auditor, and the State Auditor shall cause transfer to
- 33 be made from one item to another.

34

35 SECTION 5. Any balances remaining on June 30, 1991 in the appropriations

1 enacted in any act to defray the expenses of the House of Representatives of 2 the Seventy-Eighth General Assembly may be carried forward into the fiscal 3 year ending June 30, 1992, there to be available for the same purposes. Any 4 balance remaining on June 30, 1992 in the appropriation carried forward shall 5 be carried forward into the fiscal year ending June 30, 1993, there to be 6 available for the same purposes. SECTION 6. The funds appropriated in this Act shall be used to defray the 9 necessary expenses of the operation of the Office of the Speaker of the House 10 of Representatives, the Office of the Coordinator of House Legislative 11 Services, the Office of Parliamentarian, the Chief Clerk's Office, and other 12 reasonable and necessary expenses of the House of Representatives of the 13 Seventy-Eighth General Assembly incurred during biennial period ending June 14 30, 1993. 15 16 SECTION 7. (A) The General Assembly hereby determines that the 17 conducting of an Institute of Legislative Procedure prior to the convening of 18 regular Sessions of the General Assembly on rules and legislative procedure 19 and current fiscal conditions and other problems in state government, is 20 essential to the proper functioning of each Regular Session of the General 21 Assembly. 22 The Arkansas Senate, the Arkansas House of Representatives, the Arkansas 23 Legislative Council, and the Legislative Joint Auditing Committee shall 24 cooperate in jointly sponsoring a biennial Institute of Legislative Procedure 25 to carry out the aforementioned purposes. Members of the preceding General 26 Assembly who have been re-elected to a new term in either house of the General 27 Assembly, and the newly-elected members of the House of Representatives and 28 Senate shall be eligible to attend the biennial Institute of Legislative 29 Procedure and shall be entitled, upon filing claim therefor, to per diem in 30 the amount fixed by law for members of the General Assembly to receive for 31 attendance at legislative sessions, per day for each day in attending the 32 biennial Institute of Legislative Procedure, but in no event to exceed three 33 (3) days per member, plus mileage in traveling from their place of residence 34 to the biennial Institute of Legislative Procedure and return at the same rate 35 of mileage authorized for official travel by state employees. Per diem and

1 mileage for members of the General Assembly and newly-elected members of the 2 General Assembly for attending the biennial Institute of Legislative Procedure 3 shall be paid by the respective houses from the monies appropriated therefor. (B) There is hereby appropriated, to be payable from the Constitutional 5 Officers Fund, to the House of Representatives of the General Assembly of the 6 State of Arkansas, to be used for payment of per diem and mileage of members 7 of the House of Representatives and newly-elected members of the House of 8 Representatives who attend the biennial Institute of Legislative Procedure, to 9 be held prior to the convening of the 1993 Regular Session of the General 11 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General 12 13 Assembly that any funds disbursed under the authority of the appropriations 14 contained in this Act shall be in compliance with the stated reasons for which 15 this Act was adopted, as evidenced by the Agency Requests, Executive 16 Recommendations and Legislative Recommendations contained in the budget 17 manuals prepared by the Department of Finance and Administration, letters, or 18 summarized oral testimony in the official minutes of the Arkansas Legislative 19 Council or Joint Budget Committee which relate to its passage and adoption. 20 21 SECTION 9. CODE. All provisions of this Act of a general and permanent 22 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 23 Code Revision Commission shall incorporate the same in the Code. 2.4 25 SECTION 10. SEVERABILITY. If any provision of this Act or the 26 application thereof to any person or circumstance is held invalid, such 27 invalidity shall not affect other provisions or applications of the Act which 28 can be given effect without the invalid provision or application, and to this 29 end the provisions of this Act are declared to be severable. 30 31 SECTION 11. GENERAL REPEALER. All laws and parts of laws in conflict 32 with this Act are hereby repealed. 33 SECTION 12. EMERGENCY CLAUSE. It is hereby found and determined by the 34

35 Seventy-Eighth General Assembly, that the Constitution of the State of

1 Arkansas prohibits the appropriation of funds for more than a two (2) year
 2 period; that the effectiveness of this Act on July 1, 1991 is essential to the
 3 operation of the agency for which the appropriations in this Act are provided,
 4 and that in the event of an extension of the Regular Session, the delay in the
 5 effective date of this Act beyond July 1, 1991 could work irreparable harm
 6 upon the proper administration and provision of essential governmental
 7 programs. Therefore, an emergency is hereby declared to exist and this Act
 8 being necessary for the immediate preservation of the public peace, health and
9 safety shall be in full force and effect from and after July 1, 1991.
