HOUSE BILL 1559

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF EDUCATION -
10 ARKANSAS STATE LIBRARY FOR THE BIENNIAL PERIOD ENDING JUNE
11 30, 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. REGULAR SALARIES. There is hereby established for the
16 Department of Education - Arkansas State Library for the 1991-93 biennium, the
17 following maximum number of regular employees whose salaries shall be governed
18 by the provisions of the Uniform Classification and Compensation Act (Arkansas
19 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
20 Provided, however, that any position to which a specific maximum annual salary
21 is set out herein in dollars, shall be exempt from the provisions of said
22 Uniform Classification and Compensation Act. All persons occupying positions
23 authorized herein are hereby governed by the provisions of the Regular
24 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
25 successor.

19 SECTION 2. EXTRA HELP - STATE. There is hereby authorized, for the

20 Department of Education - Arkansas State Library - State for the 1991-93

21 biennium, the following maximum number of part-time or temporary employees, to

22 be known as "Extra Help", payable from funds appropriated herein for such

23 purposes: Seven (7) temporary or part-time employees, when needed, at rates

24 of pay not to exceed those provided in the Uniform Classification and

25 Compensation Act, or its successor, or this act for the appropriate

26 classification.

27

28 SECTION 3. APPROPRIATIONS - STATE. There is hereby appropriated, to the

29 Department of Education - Arkansas State Library - State, to be payable from

30 the State Library Fund Account, for personal services and operating expenses

31 of the Department of Education - Arkansas State Library for the biennial

32 period ending June 30, 1993, the following:

14 SECTION 4. EXTRA HELP - FEDERAL. There is hereby authorized, for
15 the Department of Education - Arkansas State Library - Federal for the 1991-93
16 biennium, the following maximum number of part-time or temporary employees, to
17 be known as "Extra Help", payable from funds appropriated herein for such
18 purposes: Five (5) temporary or part-time employees, when needed, at rates of
19 pay not to exceed those provided in the Uniform Classification and
20 Compensation Act, or its successor, or this act for the appropriate
21 classification.

22

23 SECTION 5. APPROPRIATIONS - FEDERAL. There is hereby appropriated, to
24 the Department of Education - Arkansas State Library - Federal, to be payable
25 from the federal funds as designated by the Chief Fiscal Officer of the State,
26 for personal services and operating expenses of the Department of Education -
27 Arkansas State Library for the biennial period ending June 30, 1993, the
28 following:

10 SECTION 6. APPROPRIATIONS - REVOLVING. There is hereby appropriated, to

11 the Department of Education - Arkansas State Library - Revolving, to be

12 payable from the State Library Revolving Fund, for operating expenses of the

13 Department of Education - Arkansas State Library for the biennial period

14 ending June 30, 1993, the following:

27 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

28 authorized by this Act shall be limited to the appropriation for such agency

29 and funds made available by law for the support of such appropriations; and

30 the restrictions of the State Purchasing Law, the General Accounting and

31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

32 Procedures and Restrictions Act, or their successors, and other fiscal control

33 laws of this State, where applicable, and regulations promulgated by the

34 Department of Finance and Administration, as authorized by law, shall be

35 strictly complied with in disbursement of said funds.

2 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General
3 Assembly that any funds disbursed under the authority of the appropriations
4 contained in this Act shall be in compliance with the stated reasons for which
5 this Act was adopted, as evidenced by the Agency Requests, Executive
6 Recommendations and Legislative Recommendations contained in the budget
7 manuals prepared by the Department of Finance and Administration, letters, or
8 summarized oral testimony in the official minutes of the Arkansas Legislative
9 Council or Joint Budget Committee which relate to its passage and adoption.

10

11 SECTION 9. CODE. All provisions of this Act of a general and permanent
12 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
13 Code Revision Commission shall incorporate the same in the Code.

14

15 SECTION 10. SEVERABILITY. If any provision of this Act or the
16 application thereof to any person or circumstance is held invalid, such
17 invalidity shall not affect other provisions or applications of the Act which
18 can be given effect without the invalid provision or application, and to this
19 end the provisions of this Act are declared to be severable.

20

21 SECTION 11. GENERAL REPEALER. All laws and parts of laws in conflict
22 with this Act are hereby repealed.

23

24 SECTION 12. HEALTH PREMIUMS. The Department of Education - Arkansas
25 State Library shall not, during the 1992-93 fiscal year, spend more for health
26 insurance per employee than the amount being contributed to the State
27 Employees Health Insurance Program.

28

29 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
30 Seventy-Eighth General Assembly, that the Constitution of the State of
31 Arkansas prohibits the appropriation of funds for more than a two (2) year
32 period; that the effectiveness of this Act on July 1, 1991 is essential to the
33 operation of the agency for which the appropriations in this Act are provided,
34 and that in the event of an extension of the Regular Session, the delay in the
35 effective date of this Act beyond July 1, 1991 could work irreparable harm

1 upon the proper administration and provision of essential governmental
2 programs. Therefore, an emergency is hereby declared to exist and this Act
3 being necessary for the immediate preservation of the public peace, health and
4 safety shall be in full force and effect from and after July 1, 1991.
