SENATE BILL 63

For An Act To Be Entitled

8 "AN ACT TO AMEND ARK. CODE ANN. §17-14-311 TO INCREASE THE
9 FEES LEVIED UNDER THE ARKANSAS ARCHITECTURAL ACT; AND FOR
10 OTHER PURPOSES."

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14 SECTION 1. Ark. Code Ann. §17-14-311(a) is hereby amended to read as
15 follows:

16 "(a) For the purpose of defraying the expenses of the examining body,
17 and as required for carrying out the provisions of this chapter, the following
18 fees and penalties shall be paid:

19 (1) For an application for examination and registration, an
20 amount to be fixed by the examining body which shall at no time exceed the sum
21 of two hundred and fifty dollars (\$250.00);

22 (2) For a certificate of registration by exemption, or by
23 transfer of registration from another state or country, an amount to be fixed
24 by the examining body which shall at no time exceed the sum of two hundred and
25 fifty dollars (\$250.00);

26 (3) For annual renewal of the registration certificate, an amount
27 to be fixed by the examining body which shall at no time exceed the sum of
28 fifty dollars (\$50.00);

29 (4) For the restoration of a revoked certificate, an amount to be
30 fixed by the examining body which shall at no time exceed the annual renewal
31 fees in effect plus a penalty of fifty dollars (\$50.00) for each month for the
32 first three (3) months during which time the certificate has been revoked;
33 thereafter, an additional penalty of one hundred dollars (\$100.00) for the
34 balance of one (1) year for a maximum penalty of two hundred and fifty dollars
35 (\$250.00);

36 (5) For a certificate of registration for a corporation, an

1 amount to be fixed by the examining body which shall at no time exceed the sum
2 of fifty dollars (\$50.00)."

4 SECTION 2. All provisions of this act of a general and permanent nature
5 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
6 Revision Commission shall incorporate the same in the Code.

7

8 SECTION 3. If any provision of this act or the application thereof to
9 any person or circumstance is held invalid, such invalidity shall not affect
10 other provisions or applications of the act which can be given effect without
11 the invalid provision or application, and to this end the provisions of this
12 act are declared to be severable.

13

14 SECTION 4. All laws and parts of laws in conflict with this act are
15 hereby repealed.
