SENATE BILL 238

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES FOR
9 THE OFFICE OF LIEUTENANT GOVERNOR WHICH SHALL BE
10 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS APPROPRIATED
11 BY ACT 32 OF THE FIRST EXTRAORDINARY SESSION OF 1989, FOR
12 THE FISCAL YEAR ENDING JUNE 30, 1991; AND FOR OTHER
13 PURPOSES."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. REGULAR SALARIES. There is hereby established for the
18 Office of Lieutenant Governor for the 1989-91 biennium, the following maximum
19 number of regular employees which shall be supplemental and in addition to
20 those positions authorized in Section 1 of Act 32 of the First Extraordinary
21 Session of 1989 and whose salaries shall be governed by the provisions of the
22 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et
23 seq.), or its successor, and all laws amendatory thereto. Provided, however,
24 that any position to which a specific maximum annual salary is set out herein
25 in dollars, shall be exempt from the provisions of said Uniform Classification
26 and Compensation Act. All persons occupying positions authorized herein are
27 hereby governed by the provisions of the Regular Salaries Procedures and
28 Restrictions Act (Arkansas Code §21-5-101), or its successor.

1 SECTION 2. Item (2) of Section 1 of Act 32 of the First Extraordinary
2 Session of 1989 is hereby repealed.

3

4 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the Office
5 of Lieutenant Governor, to be payable from the State Central Services Fund,
6 for personal services of the Office of Lieutenant Governor which shall be
7 supplemental and in addition to those funds appropriated in Section 3 of Act
8 32 of the First Extraordinary Session of 1989, for the remainder of the fiscal
9 year ending June 30, 1991, the following:

17 SECTION 4. FUNDING TRANSFER. Immediately upon the effective date of
18 this Act, the Chief Fiscal Officer of the State shall transfer on his books
19 and those of the State Treasurer the sum of \$27,817 from the General Revenue
20 Allotment Reserve Fund to the State Central Services Fund to provide funds
21 for the appropriation provided herein.

23 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
24 authorized by this Act shall be limited to the appropriation for such agency
25 and funds made available by law for the support of such appropriations; and
26 the restrictions of the State Purchasing Law, the General Accounting and
27 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
28 Procedures and Restrictions Act, or their successors, and other fiscal control
29 laws of this State, where applicable, and regulations promulgated by the
30 Department of Finance and Administration, as authorized by law, shall be
31 strictly complied with in disbursement of said funds.

33 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General
34 Assembly that any funds disbursed under the authority of the appropriations
35 contained in this Act shall be in compliance with the stated reasons for which

1 this Act was adopted, as evidenced by the Agency Requests, Executive
2 Recommendations and Legislative Recommendations contained in the budget
3 manuals prepared by the Department of Finance and Administration, letters, or
4 summarized oral testimony in the official minutes of the Arkansas Legislative
5 Council or Joint Budget Committee which relate to its passage and adoption.

7 SECTION 7. CODE. All provisions of this Act of a general and permanent
8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
9 Code Revision Commission shall incorporate the same in the Code.

10

11 SECTION 8. SEVERABILITY. If any provision of this Act or the
12 application thereof to any person or circumstance is held invalid, such
13 invalidity shall not affect other provisions or applications of the Act which
14 can be given effect without the invalid provision or application, and to this
15 end the provisions of this Act are declared to be severable.

16

17 SECTION 9. GENERAL REPEALER. All laws and parts of laws in conflict
18 with this Act are hereby repealed.

19

20 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the
21 Seventy-Eighth General Assembly, that funds provided by the Seventy-Seventh
22 General Assembly for the operations of the Office of Lieutenant Governor are,
23 due to unforeseen circumstances, insufficient for the Office of Lieutenant
24 Governor to continue to provide essential governmental services; that the
25 provisions of this act will provide the necessary monies for the Office of
26 Lieutenant Governor to continue such services; and that a delay in the
27 effective date of this Act could work irreparable harm upon the proper
28 administration and provision of essential governmental programs. Therefore,
29 an emergency is hereby declared to exist and this Act being necessary for the
30 immediate preservation of the public peace, health and safety shall be in full
31 force and effect from and after the date of its passage and approval.
