"AN ACT TO PROVIDE THAT ALL POWERS, FUNCTIONS AND DUTIES

16

HERETOFORE VESTED IN OR EXERCISED BY THE REVIEW

17

SUBCOMMITTEE OF THE LEGISLATIVE COUNCIL OR BY THE

18

LEGISLATIVE COUNCIL AFTER RECEIVING RECOMMENDATIONS OF THE

19

REVIEW SUBCOMMITTEE, SHALL HEREAFTER BE VESTED IN AND

20

EXERCISED BY THE APPROPRIATE SUBJECT MATTER JOINT INTERIM

21

COMMITTEES OF THE GENERAL ASSEMBLY; AND FOR OTHER

22

PURPOSES."

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25

26 SECTION 1. For the purposes of this act, the following terms shall have
27 the respective meanings as herein set forth, unless the context hereof clearly
28 indicates otherwise.

29 (a) "State agency" shall mean any officer, office, board, commission,

30 department, council, bureau, institution or other agency of the state of

31 Arkansas.

32 (b) "Joint interim committee of the General Assembly" shall mean and

33 include the joint interim committees of the General Assembly as established by

34 Arkansas Code 10-3-203(3)(A) and 10-3-701.

35

36 SECTION 2. All powers, functions and duties heretofore vested in or

1 exercised by the Review Subcommittee of the Legislative Council or by the
2 Legislative Council after receiving recommendations of the Review
3 Subcommittee, are hereby vested in and shall hereafter be exercised by the
4 appropriate subject matter joint interim committees of the General Assembly.

5
6 SECTION 3. (a) All matters required to be submitted by the various
7 state agencies to the Review Subcommittee of the Legislative Council or
8 required to be submitted to the Legislative Council and which have in the past
9 been referred to the Review Subcommittee for review shall hereafter be
10 *submitted to the respective joint interim committees of the General Assembly.*
11 *Such matters shall be submitted to the appropriate joint interim committees*
12 *as provided herein at the same time and in the same manner as such matters*
13 *were heretofore submitted to the Legislative Council or the subcommittee of*
14 *the Council.*

15 *For the purposes of this act, the joint interim committees listed below*
16 *shall have jurisdiction of matters submitted by the respective state agencies*
17 *pursuant to this act:*

18 *PUBLIC HEALTH, WELFARE AND LABOR.*

26 *Any state agency heretofore required to submit matters to the*
27 *Legislative Council or to the Review Subcommittee of the Legislative Council,*
28 *which agency is not listed above, shall file such matters with the Joint*
29 *Interim Committee on State Agencies and Governmental Affairs until such time*
30 *as the Legislative Council shall determine the appropriate joint interim*
31 *committee to review such matters. Provided, the Legislative Council shall not*
32 *refer any such matters to the Legislative Council or to a subcommittee of the*
33 *Legislative Council for review.*

34 **(b)** *At the next regular or special meeting of a joint interim*
35 *committee, all such matters referred to said committee subsequent to the last*

1 meeting of the committee or designated subcommittee thereof, shall be placed
2 on the agenda for the meeting of such joint interim committee, together with
3 any staff report or comments in regard thereto.

4 (c) Notice that such item is being placed on the meeting agenda of said
5 joint interim committee may be furnished to the various state agencies
6 involved upon direction of the co-chairmen of the joint interim committee in
7 order that the respective agencies may be represented at such joint interim
8 committee meeting to explain the matter, and to answer questions in regard
9 thereto if raised by the committee.

10 (d) Upon conclusion of the committee's consideration of any matter, the
11 committee shall notify the state agency that it has completed its review.

12

13 SECTION 4. Whenever the General Assembly is meeting in regular or
14 special session, the House of Representatives and Senate standing committees
15 may meet jointly at a time agreed upon by both chairmen to review matters
16 referred to the committee since convening of the session or pending at the
17 time the session was convened.

18

19 SECTION 5. *The respective joint interim committees of the General*
20 *Assembly shall adopt appropriate procedures and practices including the*
21 *utilization of subcommittees to enable the committees to carry out their*
22 *responsibilities under the provisions of this Act.*

23

24 SECTION 6. All provisions of this act of a general and permanent nature
25 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
26 Revision Commission shall incorporate the same in the Code.

27

28 SECTION 7. If any provision of this act or the application thereof to
29 any person or circumstance is held invalid, such invalidity shall not affect
30 other provisions or applications of the act which can be given effect without
31 the invalid provision or application, and to this end the provisions of this
32 act are declared to be severable.

33

34 SECTION 8. All laws and parts of laws in conflict with this act are
35 hereby repealed.
