14 **For An Act To Be Entitled**

15 "AN ACT TO PROVIDE THAT ALL POWERS, FUNCTIONS AND DUTIES
16 HERETOFORE VESTED IN OR EXERCISED BY THE PERFORMANCE
17 EVALUATION AND EXPENDITURE REVIEW SUBCOMMITTEE OF THE
18 LEGISLATIVE COUNCIL OR BY THE LEGISLATIVE COUNCIL AFTER
19 RECEIVING RECOMMENDATIONS OF THE PERFORMANCE EVALUATION
20 AND EXPENDITURE REVIEW SUBCOMMITTEE, SHALL HEREAFTER BE
21 VESTED IN AND EXERCISED BY THE APPROPRIATE SUBJECT MATTER
22 JOINT INTERIM COMMITTEES OF THE GENERAL ASSEMBLY; AND FOR
23 OTHER PURPOSES."

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26
27 SECTION 1. For the purposes of this act, the following terms shall have
28 the respective meanings as herein set forth, unless the context hereof clearly
29 indicates otherwise.

30 (a) "State agency" shall mean any officer, office, board, commission,
31 department, council, bureau, institution or other agency of the state of
32 Arkansas.

33 (b) "Joint interim committee of the General Assembly" shall mean and
34 include the joint interim committees of the General Assembly as established by
35 Arkansas Code 10-3-203(3)(A) and 10-3-701.

SECTION 2. All powers, functions and duties heretofore vested in or exercised by the Performance Evaluation and Expenditure Review Subcommittee of the Legislative Council or by the Legislative Council after receiving recommendations of the Performance Evaluation and Expenditure Review Subcommittee, are hereby vested in and shall hereafter be exercised by the respective appropriate joint interim committees of the General Assembly.

SECTION 3. (a) All matters required to be submitted by the various state agencies to the Performance Evaluation and Expenditure Review Subcommittee of the Legislative Council or required to be submitted to the Legislative Council and which have in the past been referred to the Performance Evaluation and Expenditure Review Subcommittee for review shall hereafter be submitted to the respective joint interim committees of the General Assembly. Such matters shall be submitted to the appropriate joint interim committees as provided herein at the same time and in the same manner as such matters were heretofore submitted to the Legislative Council or the subcommittee of the Council.

For purposes of this act, the Joint Interim Committee listed below shall have jurisdiction of matters submitted by the respective state agencies pursuant this act:

29 *All matters required to be submitted by any state agency, which agency*
30 *is not listed above, shall be submitted to the Joint Interim Committee on*
31 *State Agencies and Governmental Affairs for its review until such time as the*
32 *Legislative Council determines the appropriate joint interim committee to*
33 *review matters submitted by that agency. Provided, the Legislative Council*
34 *shall not refer such matters to the Legislative Council or to a subcommittee*
35 *of the Council for review.*

1 (b) At the next regular or special meeting of a joint interim
2 committee, all such matters referred to the committee subsequent to the last
3 meeting of the committee or designated subcommittee thereof, shall be placed
4 on the agenda for the meeting of such joint interim committee, together with
5 any staff report and comments in regard thereto.

6 (c) Notice that such item is being placed on the meeting agenda of said
7 joint interim committee may be furnished to the various state agencies
8 involved upon direction of the co-chairmen of the joint interim committee in
9 order that the respective agencies may be represented at such joint interim
10 committee meeting to explain the matter, and to answer questions in regard
11 thereto if raised by the committee.

12 (d) Upon conclusion of the committee's consideration of any matter,
13 the committee or designated subcommittee thereof shall notify the state agency
14 that it has completed its review.

15

16 SECTION 4. Whenever the General Assembly is meeting in regular or
17 special session, the House of Representatives and Senate standing committees
18 may meet jointly at a time agreed upon by both chairmen to review matters
19 referred to the committee since convening of the session or pending at the
20 time the session was convened.

21

22 SECTION 5. *The respective joint interim committees of the General*
23 *Assembly are hereby authorized to adopt appropriate procedures and practices*
24 *including utilization of subcommittees to enable the respective committees to*
25 *carry out their responsibilities under the provisions of this act.*

26

27 SECTION 6. All provisions of this act of a general and permanent nature
28 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
29 Revision Commission shall incorporate the same in the Code.

30

31 SECTION 7. If any provision of this act or the application thereof to
32 any person or circumstance is held invalid, such invalidity shall not affect
33 other provisions or applications of the act which can be given effect without
34 the invalid provision or application, and to this end the provisions of this
35 act are declared to be severable.
