Arkansas Code 6-16-603(3) is hereby amended to read as 16 follows: "(3) During a time frame to be established by the State Board of 17 18 Education, every eleventh-grade student enrolled in a public school of 19 Arkansas who chooses to do so may take a placement test which has been designated by the State Board of Higher Education." 21 22 SECTION 2. Arkansas Code 6-16-604(a) is hereby amended to read as 23 follows: "(a) Students who plan to enroll in postsecondary programs in Arkansas 2.4 25 may enroll in a state-approved intensive noncredit preparatory program during 26 the summer following the junior year of high school. The Department of 27 Education is also authorized to permit the enrollment in such programs of 28 Arkansas high school graduates." 29 3 0 SECTION 3. Arkansas Code 6-16-604 is hereby amended by adding the 31 following two new subdivisions at the end thereof: "(g) Students who complete the summer College Preparatory Enrichment 32 33 Program successfully and who enroll in an appropriate mathematics or English 34 course, as determined by the Departments of Education and Higher Education, 35 during the senior year of high school, may take the placement test designated

36 by the State Board of Higher Education under Section 3(b) at no cost to the

              The Departments of Education and Higher Education are authorized to
 3 collect such information as may be necessary for the evaluation of each
 4 program including student identification data, student test scores, college
 5 placement status, and student grades in first-year college courses. This
 6 information shall be provided to the Departments by public schools, colleges
 7 and universities, and shall be used to evaluate and improve the programs
 8 authorized by this act."

         SECTION 4. All provisions of this act of a general and permanent nature
10
11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
12 Revision Commission shall incorporate the same in the Code.

         SECTION 5. If any provision of this act or the application thereof to
15 any person or circumstance is held invalid, such invalidity shall not affect
16 other provisions or applications of the act which can be given effect without
17 the invalid provision or application, and to this end the provisions of this
18 act are declared to be severable.

         SECTION 6. All laws and parts of laws in conflict with this act are
21 hereby repealed.

         SECTION 7. EMERGENCY. It is hereby found and determined by the General
23
24 Assembly that the remedial program for high school students is now limited to
25 graduates; that in order to realize the full potential of the program, it is
26 necessary that it be expanded to include students who have completed the
27 junior year of high school; that this act is designed to accomplish this
28 purpose and should be given effect immediately. Therefore, an emergency is
29 hereby declared to exist and this act being necessary for the preservation of
30 the public peace, health and safety shall be in full force and effect from and
31 after its passage and approval.
