# A Bill ACT 918 OF 1991

## HOUSE BILL 1869

### For An Act To Be Entitled

8 "AN ACT TO AMEND SUBCHAPTERS 2 AND 3 OF TITLE 27, CHAPTER  
9 35 OF THE ARKANSAS CODE OF 1987, ANNOTATED TO ADD ARKANSAS  
10 CODE § 27-35-213 TO ALLOW PERSONS PERMITTED UNDER THE  
11 OVERWEIGHT AND OVERSIZE PERMITS TO TEMPORARILY STOP AND  
12 DIRECT TRAFFIC WHILE MANEUVERING THEIR OVERWEIGHT OR  
13 OVERSIZE PAYLOADS ON OR OFF THE HIGHWAY AND TO ADD  
14 ARKANSAS CODE § 27-35-310 TO ALLOW PERSONS PERMITTED TO  
15 MOVE MANUFACTURED HOMES AND HOUSES TO TEMPORARILY STOP AND  
16 DIRECT TRAFFIC WHILE MANEUVERING THEIR MANUFACTURED HOMES  
17 OR HOUSES ON OR OFF THE HIGHWAY; AND FOR OTHER PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Subchapter 2 of Title 27, Chapter 35 of the Arkansas Code of  
22 1987, Annotated is hereby amended to add new section Arkansas Code § 27-35-213  
23 to read as follows:

24 "27-35-213. Permitted persons to stop and direct traffic.

25 In addition to the requirements on persons and payloads issued  
26 overweight or oversize permits to move on Arkansas highways under Arkansas  
27 Code § 27-35-210, a person issued an overweight or oversize permit under this  
28 subchapter shall be authorized to temporarily stop or halt traffic and safely  
29 direct, control, and regulate traffic around the overweight or oversize  
30 payload while maneuvering their overweight or oversize payloads on or off the  
31 public streets or highways. Provided, however, that no overweight or oversize  
32 permitted payload shall ever halt or stop traffic on a public street or  
33 highway while maneuvering on or off the street or highway for more than three  
34 (3) minutes in time or stop or halt traffic within five hundred (500) feet  
35 from the crest of a hill."

1 SECTION 2. Subchapter 3 of Title 27, Chapter 35 of the Arkansas Code of  
2 1987, Annotated is hereby amended to add new section Arkansas Code § 27-35-310  
3 to read as follows:

4 "27-35-310. Persons permitted to move manufactured homes and houses to  
5 stop and direct traffic.

6 In addition to the requirements on persons and payloads issued permits  
7 to move manufactured homes and houses on Arkansas highways under Arkansas Code  
8 § 27-35-304 and § 27-35-309, a person issued a permit to move manufactured  
9 homes or houses under this subchapter shall be authorized to temporarily stop  
10 or halt traffic and safely direct, control, and regulate traffic around the  
11 manufactured home or house while maneuvering their payloads on or off the  
12 public streets or highways. Provided, however, that no permitted manufactured  
13 home or house shall ever halt or stop traffic on a public street or highway  
14 while maneuvering on or off the street or highway for more than three (3)  
15 minutes in time or stop or halt traffic within five hundred (500) feet from  
16 the crest of a hill."

18 SECTION 3. All provisions of this act of general and permanent nature  
19 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
20 Revision Commission shall incorporate the same in the Code.

21

22 SECTION 4. If any provisions of this act or the application thereof to  
23 any person or circumstance is held invalid, the invalidity shall not affect  
24 other provisions or applications of the act which can be given effect without  
25 the invalid provisions or application, and to this end the provisions of this  
26 act are declared to be severable.

27

28 SECTION 5. All laws and parts of laws in conflict with this act are  
29 hereby repealed.
