7 **For An Act To Be Entitled**

8 *"AN ACT TO PRESCRIBE THE METHOD OF APPOINTMENT OF HOUSE*
9 *MEMBERS OF THE JOINT COMMITTEE ON ENERGY; TO PROVIDE FOR*
10 *THE SELECTION OF THE HOUSE CO-VICE CHAIRMAN OF THE*
11 *COMMITTEE; TO PROVIDE THAT THE HIGHEST RANKING HOUSE*
12 *MEMBER ON THE COMMITTEE SHALL BE THE HOUSE CO-CHAIRMAN OF*
13 *THE COMMITTEE, AND THE SECOND HIGHEST RANKING HOUSE MEMBER*
14 *OF THE COMMITTEE SHALL BE THE HOUSE CO-VICE CHAIRMAN OF*
15 *THE COMMITTEE; AND FOR OTHER PURPOSES."*

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 *SECTION 1. Notwithstanding Arkansas Code 10-3-802 or any other law to*
20 *the contrary, once the House members and House alternate members of the Joint*
21 *Committee on Energy are appointed, the Speaker shall thereafter make*
22 *appointments only to fill vacancies in House member and House alternate member*
23 *positions on the Committee. The highest ranking House member of the Committee*
24 *shall be the House Co-Chairman of the Committee, and the second highest*
25 *ranking House member of the Committee shall be the House Co-Vice Chairman of*
26 *the Committee, except that the House Co-Chairman and Co-Vice Chairman of the*
27 *Joint Committee on Energy serving on the effective date of this Act shall*
28 *retain their positions regardless of their seniority on the Committee.*

31 *SECTION 2. All provisions of this act of a general and permanent nature*
32 *are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code*
33 *Revision Commission shall incorporate the same in the Code.*

35 *SECTION 3. If any provision of this act or the application thereof to*
36 *any person or circumstance is held invalid, such invalidity shall not affect*

1 other provisions or applications of the act which can be given effect without
2 the invalid provision or application, and to this end the provisions of this
3 act are declared to be severable.

5 SECTION 4. All laws and parts of laws in conflict with this act are
6 hereby repealed.
