Arkansas Code 26-51-813 is hereby amended to add the 2.4 25 following paragraph (g) at the end thereof: "(g) Nothing in this section shall be construed to prohibit the 26 27 Department of Finance and Administration from disclosing from any return or 28 other record maintained by the director to the Arkansas Department of Higher 29 Education or any Arkansas Public Institution of Higher Education the last 30 known address or whereabouts and/or the last known employer of any person from 31 whom these institutions are charged with collecting student indebtedness. 32 providing this information the department shall not allow the said Arkansas 33 Department of Higher Education or the Arkansas Public Institutions of Higher 34 Education to examine the tax return." 35

SECTION 2. Arkansas Code 26-18-303(b)(9) is hereby amended to read as

1 follows: "(9) Disclosure to the Arkansas Student Loan Authority, the Arkansas 3 Department of Higher Education, the Student Loan Guarantee Foundation of 4 Arkansas, or any Arkansas Public Institution of Higher Education of the last 5 known address or whereabouts or the last known employer of any person from 6 whom these agencies are charged with collecting a student loan or other 7 student indebtedness. In providing such information, the director shall not 8 allow the Arkansas Student Loan Authority, the Student Loan Guarantee 9 Foundation of Arkansas, the Arkansas Department of Higher Education, or any 10 Arkansas Public Institution of Higher Education to examine the tax return;" 11 SECTION 3. All provisions of this act of a general and permanent nature 12 13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 14 Revision Commission shall incorporate the same in the Code. 15 16 SECTION 4. If any provision of this act or the application thereof to 17 any person or circumstance is held invalid, such invalidity shall not affect 18 other provisions or applications of the act which can be given effect without 19 the invalid provision or application, and to this end the provisions of this 20 act are declared to be severable. 2.1 22 SECTION 5. All laws and parts of laws in conflict with this act are 23 hereby repealed. 2.4 25 SECTION 6. EMERGENCY. It is hereby found and determined by the General 26 Assembly that the Arkansas Public Institutions of Higher Education are charged 27 with collecting student indebtedness and that in some cases those institutions 28 are unable to locate persons who fail to make payment of their student 29 indebtedness; that all reasonable assistance should be given those agencies in 30 locating persons who fail to pay or repay student tuition, fees, loans, and 31 other student indebtedness; that this act is designed to aid those
