HOUSE BILL 1829

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE SECTION 23-13-225 TO DELETE
9 THE PROVISION THAT NO CONTRACT CARRIER BY MOTOR VEHICLE
10 SHALL BE ISSUED A PERMIT BY THE STATE HIGHWAY COMMISSION
11 FOR A TOTAL MILEAGE IN EXCESS OF FIFTY PERCENT (50%) OF
12 THE TOTAL MILEAGE WITHIN THE STATE HIGHWAY SYSTEM; AND FOR
13 OTHER PURPOSES."

15 "AN ACT TO AMEND ARKANSAS CODE SECTION 23-13-225 RELATING

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 23-13-225 is hereby amended to read as
22 follows:

23 "23-13-225. Permits for contract carriers - Terms and conditions -
24 Contracts for services.

25 (a) The Arkansas State Highway Commission shall specify in the permit
26 for a contract carrier by motor vehicle the business of the contract carrier
27 covered thereby and the scope thereof. The commission shall attach to the
28 permit, at the time of issuance, and from time to time thereafter, such
29 reasonable terms, conditions, and limitations consistent with the character of
30 the holder as a contract carrier as are necessary to carry out, with respect
31 to the operations of such carrier, the requirements established by the
32 commission under this subchapter.

33 (b) (1) The commission shall not issue any permit which will authorize
34 any contract carrier to have in effect, at any one (1) time, more than six (6)
35 contracts, such contracts to be filed with and approved by the commission
36 prior to granting of such authority.

1 (2) When any contract expires, the commission shall be given notice
2 thereof, and if any new contract is substituted or added, the contract shall
3 be filed with and approved by the commission before operation thereunder.

4 (c) No permit issued under this subchapter shall confer any proprietary
5 or property rights in the use of public highways."
6

7 SECTION 2. All provisions of this Act of general and permanent nature
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
9 Revision Commission shall incorporate the same in the Code.
10

11 SECTION 3. If any provisions of this Act or the application thereof to
12 any person or circumstance is held invalid, the invalidity shall not affect
13 other provisions or applications of the act which can be given effect without
14 the invalid provisions or applications, and to this end the provisions of this
15 Act are declared to be severable.
16

17 SECTION 4. All laws and parts of laws in conflict with this Act are
18 hereby repealed.
