Arkansas Code Section 27-35-208 is hereby amended by adding 22 an additional subsection (f) thereto to read as follows: 23 "(f) No motor vehicle shall be operated on the highways, roads or 24 streets of this state with more than two (2) trailing vehicles." 2.5 SECTION 2. All provisions of this act of a general and permanent nature 26 27 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 28 Revision Commission shall incorporate the same in the Code. 29 30 SECTION 3. If any provision of this act or the application thereof to 31 any person or circumstance is held invalid, such invalidity shall not affect 32 other provisions or applications of the act which can be given effect without 33 the invalid provision or application, and to this end the provisions of this 34 act are declared to be severable. SECTION 4. All laws or parts of laws in conflict with this act are 35 36 hereby repealed.
