For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE TITLE 4, CHAPTER 90,
9 SUBCHAPTER 2 PERTAINING TO ODOMETER FRAUD, PROVIDING THAT
10 VIOLATIONS SHALL CONSTITUTE A DECEPTIVE TRADE PRACTICE ACT
11 AS DEFINED BY ARKANSAS CODE ANNOTATED § 4-88-101 ET SEQ.;
12 AND FOR OTHER PURPOSES."

Subtitle

15 "AN ACT TO PROVIDE THAT ODOMETER FRAUD VIOLATIONS SHALL
16 CONSTITUTE A DECEPTIVE TRADE PRACTICE."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code Annotated § 4-90-202 is hereby amended to read
21 as follows:

22 "(a) Any person who is found to have violated this subchapter shall be
23 guilty of a misdemeanor and imprisoned not more than one (1) year and subject
24 to a fine of not more than one thousand dollars (\$1,000).

25 (b) Violation of any of the provisions of this Subchapter shall
26 constitute an unfair or deceptive act or practice as defined by the Deceptive
27 Trade Practices Act, A.C.A. § 4-88-101 et seq. All remedies, penalties, and
28 authority granted to the Attorney General under the Deceptive Trade Practices
29 Act shall be available to the Attorney General for the enforcement of this
30 Act."

31

32 SECTION 2. All provisions of this act of a general and permanent nature
33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
34 Revision Commission shall incorporate the same in the Code.

35

36 SECTION 3. If any provision of this act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
2 other provisions or applications of the act which can be given effect without
3 the invalid provision or application, and to this end the provisions of this
4 act are declared to be severable.

5

6 SECTION 4. All laws and parts of laws in conflict with this act are
7 hereby repealed.
