For An Act To Be Entitled

8 "AN ACT TO AUTHORIZE THE ADJUTANT GENERAL TO ESTABLISH AND
9 OPERATE A MILITARY TYPE SERVICE CLUB AT EBBING AIR
10 NATIONAL GUARD FIELD IN FORT SMITH, SEBASTIAN COUNTY,
11 ARKANSAS; AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT TO AUTHORIZE A MILITARY TYPE SERVICE CLUB AT
15 EBBING AIR NATIONAL GUARD FIELD."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. (a) The Adjutant General of the State of Arkansas is
20 authorized to establish and operate a military service club at Ebbing Air
21 National Guard Field, in the city of Fort Smith, Sebastian County, Arkansas.

22 (b) Any military service club established at Ebbing Air National Guard
23 Field shall be operated at no cost to the State of Arkansas and shall be
24 generally operated in accordance with applicable military regulations of the
25 United States Air Force pertaining to military service clubs, and in
26 accordance with the orders, directions and general supervision of the Adjutant
27 General of Arkansas. *Any military service club established at Ebbing Air*
28 *National Guard Field shall obtain all requisite state and local permits*
29 *required for its operation and shall pay any taxes due from its operation to*
30 *the state and local governments that apply to its operation. The laws of the*
31 *state and the regulations of the Alcoholic Beverage Control Divisions shall*
32 *apply to the operation of the military service club. To the extent there is a*
33 *conflict between applicable regulations of the United States Air Force*
34 *pertaining to military service clubs and laws and regulations of the state,*
35 *state laws and regulations shall control.*

1 SECTION 2. All provisions of this act of a general and permanent nature
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
3 Revision Commission shall incorporate the same in the Code.

4

5 SECTION 3. If any provision of this act or the application thereof to
6 any person or circumstance is held invalid, such invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provision or application, and to this end the provisions of this
9 act are declared to be severable.

10

11 SECTION 4. All laws and parts of laws in conflict with this act are
12 hereby repealed.
