30	(3) _Institution_ means a place for the diagnosis, treatment, or care
31	of two (2) or more persons, not related to the proprietor, suffering from
32	illness, injury, or deformity, or where obstetrical care or care of the aged,
33	blind, or disabled is rendered over a period exceeding twenty-four (24) hours.
34	The term _institutional_ also includes an outpatient surgery center, and
35	alcohol/drug abuse treatment center. No establishment operated by the federal
36	government or an agency thereof is within this definition;
