SENATE BILL 313

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION TO THE OFFICE OF THE
9 TREASURER OF STATE FOR PAYMENT TO THE CITY OF GOSNELL TO
10 CORRECT ERRORS MADE BY THE FEDERAL BUREAU OF THE CENSUS
11 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR
12 OTHER PURPOSES."

14 **"AN ACT TO PAY GOSNELL DUE TO CENSUS ERRORS."**

17 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

19 **SECTION 1. APPROPRIATIONS - GENERAL REVENUE.** There is hereby
20 appropriated, to the Office of the Treasurer of State, to be payable from general revenues
21 accruing to the County Aid Fund, to correct errors made by the Federal Bureau of the Census
22 in the 1990 federal decennial census which resulted in the underpayment of revenues to the
23 City of Gosnell, Arkansas for the biennial period ending June 30, 1993, the sum of \$52,085.18.

25 **SECTION 2. COMPLIANCE WITH OTHER LAWS.** Disbursement of funds
26 authorized by this Act shall be limited to the appropriation for such agency and funds made
27 available by law for the support of such appropriations; and the restrictions of the State
28 Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue
29 Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors,
30 and other fiscal control laws of this State, where applicable, and regulations promulgated by
31 the Department of Finance and Administration, as authorized by law, shall be strictly
32 complied with in disbursement of said funds.

34 **SECTION 3. LEGISLATIVE INTENT.** It is the intent of the General Assembly that
35 any funds disbursed under the authority of the appropriations contained in this Act shall be in
36 compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency

1 **Requests, Executive Recommendations and Legislative Recommendations contained in the**
2 **budget manuals prepared by the Department of Finance and Administration, letters, or**
3 **summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint**
4 **Budget Committee which relate to its passage and adoption.**

5

6 **SECTION 4. CODE.** All provisions of this Act of a general and permanent nature are
7 **amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision**
8 **Commission shall incorporate the same in the Code.**

9

10 **SECTION 5. SEVERABILITY.** If any provision of this Act or the application thereof
11 **to any person or circumstance is held invalid, such invalidity shall not affect other provisions**
12 **or applications of the Act which can be given effect without the invalid provision or application,**
13 **and to this end the provisions of this Act are declared to be severable.**

14

15 **SECTION 6. GENERAL REPEALER.** All laws and parts of laws in conflict with
16 **this Act are hereby repealed.**

17

18 **SECTION 7. EMERGENCY CLAUSE.** It is hereby found and determined by the
19 **Seventy-Ninth General Assembly, that errors in the 1990 federal decennial census resulted in**
20 **a loss of revenues to the city of Gosnell, Arkansas, and that the underpayment of turnback**
21 **funds to Gosnell should be corrected immediately in order for the city to operate in the most**
22 **efficient manner. Therefore, an emergency is hereby declared to exist and this Act being**
23 **necessary for the immediate preservation of the public peace, health and safety shall be in full**
24 **force and effect from and after its passage and approval.**
