For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE § 16-13-1004, CODIFIED ACT
9 94 OF 1991, TO PROVIDE FOR A CASE COORDINATOR FOR THE
10 CIRCUIT JUDGES IN THE SECOND JUDICIAL DISTRICT AND TO SET
11 THE SALARY FOR THE DISTRICT CASE COORDINATORS; AND FOR
12 OTHER PURPOSES."

14 **"AN ACT TO AUTHORIZE A CASE COORDINATOR FOR THE**
15 **CIRCUIT JUDGES IN THE SECOND JUDICIAL DISTRICT**
16 **AND TO SET SALARIES."**

19 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

21 **SECTION 1. Arkansas Code § 16-13-1004 is hereby amended to read as follows:**

22 **"16-13-1004. Case coordinator.**

23 **(a)(1) The judges of the Chancery and Probate Court for the Second Judicial District**
24 **may appoint one (1) case coordinator for said district for chancery and probate matters.**

25 **(2) The judges of the Circuit Court for the Second Judicial District may**
26 **appoint one (1) case coordinator for said district for circuit matters.**

27 **(b) The principal duties of the case coordinators shall be to maintain the court**
28 **calendar, schedule dates for the trial of cases and for the hearing of motions, and other related**
29 **and incidental duties at the direction of the judges.**

30 **(c)(1) Each case coordinator provided for in this section shall receive a salary of not**
31 **less than twenty-one thousand five hundred dollars (\$21,500) nor more than twenty-five**
32 **thousand dollars (\$25,000) per calendar year, which salary shall be prorated between the**
33 **counties comprising the Second Judicial District, based on the number of annual case filings**
34 **in each of such counties.**

35 **(2) When the county quorum courts raise the salaries of county employees, they**
36 **shall also raise salaries an equivalent amount for the case coordinators provided for in this**

1 **section.**

2 **(d) The reasonable expenses accruing in the offices of the case coordinators shall be**
3 **prorated among the counties comprising the district in the same manner as the salaries set**
4 **forth above and be paid out of the county treasury."**

6 **SECTION 2. All provisions of this act of general and permanent nature are**
7 **amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision**
8 **Commission shall incorporate the same in the Code.**

10 **SECTION 3. If any provisions of this act or the application thereof to any person or**
11 **circumstance is held invalid, the invalidity shall not affect other provisions or applications of**
12 **the act which can be given effect without the invalid provisions or application, and to this end**
13 **the provisions of this act are declared to be severable.**

15 **SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.**
