# A Bill

**ACT 208 OF 1993**  
**HOUSE BILL 1366**

## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE STATE BANK DEPARTMENT FOR THE  
10 BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR OTHER  
11 PURPOSES. "

## Subtitle

14 "AN ACT FOR THE STATE BANK DEPARTMENT  
15 APPROPRIATION."

17 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

19 **SECTION 1. REGULAR SALARIES.** There is hereby established for the State Bank  
20 Department for the 1993-95 biennium, the following maximum number of regular employees  
21 whose salaries shall be governed by the provisions of the Uniform Classification and  
22 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws  
23 amendatory thereto. Provided, however, that any position to which a specific maximum annual  
24 salary is set out herein in dollars, shall be exempt from the provisions of said Uniform  
25 Classification and Compensation Act. All persons occupying positions authorized herein are  
26 hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act  
27 (Arkansas Code §21-5-101), or its successor.

22       **SECTION 2. EXTRA HELP.** There is hereby authorized, for the State Bank  
23 Department for the 1993-95 biennium, the following maximum number of part-time or  
24 temporary employees, to be known as "Extra Help", payable from funds appropriated herein  
25 for such purposes: three (3) temporary or part-time employees, when needed, at rates of pay  
26 not to exceed those provided in the Uniform Classification and Compensation Act, or its  
27 successor, or this act for the appropriate classification.

29       **SECTION 3. APPROPRIATIONS.** There is hereby appropriated, to the State Bank  
30 Department, to be payable from the Bank Department Fund, for personal services and  
31 operating expenses of the State Bank Department for the biennial period ending June 30,  
32 1995, the following:

14           **SECTION 4. SPECIAL RATES OF PAY.** Due to the highly competitive job market  
15 conditions for banking industry professionals and the necessity of recruiting and retaining  
16 qualified personnel, the State Bank Department is authorized special rates of pay for current  
17 and new employees up to the levels listed under subsection (a), with additional authority and  
18 restrictions as indicated in subsections (b) and (c) below:

3 **(b) Applications for special rates of pay indicated in subsection (a) shall have been reviewed**  
4 **and approved by the Office of Personnel Management after prior review by the Arkansas**  
5 **Legislative Council.**

6

7 **(c) This special provision shall be in full force and effect for the biennium beginning July 1,**  
8 **1993, and ending June 30, 1995.**

9

10 **SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds**  
11 **authorized by this Act shall be limited to the appropriation for such agency and funds made**  
12 **available by law for the support of such appropriations; and the restrictions of the State**  
13 **Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue**  
14 **Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors,**  
15 **and other fiscal control laws of this State, where applicable, and regulations promulgated by**  
16 **the Department of Finance and Administration, as authorized by law, shall be strictly**  
17 **complied with in disbursement of said funds.**

18

19 **SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly that**  
20 **any funds disbursed under the authority of the appropriations contained in this Act shall be in**  
21 **compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency**  
22 **Requests, Executive Recommendations and Legislative Recommendations contained in the**  
23 **budget manuals prepared by the Department of Finance and Administration, letters, or**  
24 **summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint**  
25 **Budget Committee which relate to its passage and adoption.**

27 **SECTION 7. CODE. All provisions of this Act of a general and permanent nature are**  
28 **amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision**  
29 **Commission shall incorporate the same in the Code.**

30

31 **SECTION 8. SEVERABILITY. If any provision of this Act or the application thereof**  
32 **to any person or circumstance is held invalid, such invalidity shall not affect other provisions**  
33 **or applications of the Act which can be given effect without the invalid provision or application,**  
34 **and to this end the provisions of this Act are declared to be severable.**
