For An Act To Be Entitled

8 "AN ACT TO ABOLISH THE JUSTICE BUILDING COMMISSION AND
9 TRANSFER ITS POWERS AND DUTIES TO STATE BUILDING SERVICES;
10 AND FOR OTHER PURPOSES."

Subtitle

13 **"TO ABOLISH THE JUSTICE BUILDING COMMISSION AND**
14 **TRANSFER ITS POWERS AND DUTIES TO STATE BUILDING**
15 **SERVICES."**

17 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

19 **SECTION 1. The Justice Building Commission created by Arkansas Code 22-3-904**
20 **is hereby abolished and all of its powers, duties, functions, records, personnel, property,**
21 **unexpended balances of appropriations, allocations, or other funds are hereby transferred to**
22 **the Arkansas State Building Services created by Arkansas Code 22-2-104.**

24 **SECTION 2. All provisions of this act of a general and permanent nature are**
25 **amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision**
26 **Commission shall incorporate the same in the Code.**

28 **SECTION 3. If any provision of this act or the application thereof to any person or**
29 **circumstance is held invalid, such invalidity shall not affect other provisions or applications of**
30 **the act which can be given effect without the invalid provision or application, and to this end**
31 **the provisions of this act are declared to be severable.**

33 **SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.**

35 **SECTION 5. EMERGENCY. It is hereby found and determined by the General**
36 **Assembly that State Building Services should perform the duties of the Justice Building**

1 **Commission; that this act abolishes the Justice Building Commission and transfers its powers**
2 **and duties to State Building Services; that such transfer should occur at the beginning of the**
3 **next fiscal year; and that unless this emergency clause is adopted this act will not go into effect**
4 **until after the beginning of the next fiscal year. Therefore, an emergency is hereby declared to**
5 **exist and this act being necessary for the immediate preservation of the public peace, health**
6 **and safety shall be in full force and effect from and after July 1, 1993.**
