8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES OF THE OFFICIAL COURT REPORTERS OF THE
10 CIRCUIT AND CHANCERY COURTS WHICH SHALL BE SUPPLEMENTAL
11 AND IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 788 OF
12 1991, FOR THE REMAINDER OF THE BIENNIAL PERIOD ENDING JUNE
13 30, 1993; AND FOR OTHER PURPOSES."

19 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:**

21 **SECTION 1. REGULAR SALARIES.** There is hereby established for the official
22 **court reporters of the Circuit and Chancery Courts for the remainder of the 1991-93**
23 **biennium, the following maximum number of regular employees which shall be supplemental**
24 **and in addition to those positions authorized in Section 1 of Act 788 of 1991 and whose**
25 **salaries shall be governed by the provisions of the Uniform Classification and Compensation**
26 **Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.**
27 **Provided, however, that any position to which a specific maximum annual salary is set out**
28 **herein in dollars, shall be exempt from the provisions of said Uniform Classification and**
29 **Compensation Act. All persons occupying positions authorized herein are hereby governed by**
30 **the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code**
31 **§21-5-101), or its successor.**

4 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the Auditor of
5 State, to be payable from the Court Reporters' Fund, for personal services and operating
6 expenses of the official court reporters of the Circuit and Chancery Courts which shall be
7 supplemental and in addition to those funds appropriated in Section 2 of Act 788 of 1991, for
8 the remainder of the biennial period ending June 30, 1993, the following:

23 SECTION 3. The funds appropriated herein for Professional Fees and Services shall
24 be used solely for the purpose of securing court reporter services necessary as a result of the
25 displacement of four of the seven incumbent judges pursuant to the United States District
26 Court Order in the case of Eugene Hunt et al v. State of Arkansas, et al.

28 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
29 authorized by this Act shall be limited to the appropriation for such agency and funds made
30 available by law for the support of such appropriations; and the restrictions of the State
31 Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue
32 Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors,
33 and other fiscal control laws of this State, where applicable, and regulations promulgated by
34 the Department of Finance and Administration, as authorized by law, shall be strictly
35 complied with in disbursement of said funds.

SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 6. CODE. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 7. SEVERABILITY. If any provision of this Act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are declared to be severable.

SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict with this Act are hereby repealed.

SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Ninth General Assembly meeting in Regular Session, that funds provided by the Seventy-Eighth General Assembly for the operations of the Auditor of State are, due to unforeseen circumstances, insufficient for the Auditor of State to continue to provide essential governmental services; that the provisions of this act will provide the necessary monies for the Auditor of State to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.
