**ACT 267 OF 1993**  
**SENATE BILL 165**

## **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED 16-20-304 TO  
9 REQUIRE THE CLERKS OF THE CIRCUIT, CHANCERY, AND PROBATE  
10 COURTS TO INCLUDE THE SOCIAL SECURITY NUMBER OF THE  
11 JUDGMENT DEBTOR WITH ALL RECORDED PERSONAL JUDGMENTS; AND  
12 FOR OTHER PURPOSES."

## **Subtitle**

15 "TO REQUIRE THE CIRCUIT, CHANCERY AND PROBATE COURT CLERKS  
16 TO INCLUDE THE SOCIAL SECURITY NUMBER OF THE JUDGEMENT  
17 DEBTOR WITH ALL RECORDED PERSONAL JUDGEMENTS."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code Annotated 16-20-304 is amended to read as  
22 follows:

23 "16-20-304. Record and index of court proceedings.

24 Every clerk shall seasonably record the judgments, rules, orders, and  
25 other proceedings of the courts of which he is the clerk and shall make a  
26 complete alphabetical index thereto. The records of all personal judgments  
27 rendered in circuit, chancery, or probate court shall contain the Social  
28 Security number of the judgment debtor unless otherwise prohibited under  
29 *federal law, or the Social Security number is unavailable.*"  
30

31 SECTION 2. All provisions of this act of a general and permanent nature  
32 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
33 Revision Commission shall incorporate the same in the Code.  
34

35 SECTION 3. If any provision of this act or the application thereof to  
36 any person or circumstance is held invalid, such invalidity shall not affect

1 other provisions or applications of the act which can be given effect without  
2 the invalid provision or application, and to this end the provisions of this  
3 act are declared to be severable.

5 SECTION 4. All laws and parts of laws in conflict with this act are  
6 hereby repealed.
