SENATE BILL 656

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES TO THE DEPARTMENT OF FINANCE AND
10 ADMINISTRATION - DIVISION OF RACING WHICH SHALL BE
11 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS APPROPRIATED
12 BY ACT 1117 OF 1991 FOR THE REMAINDER OF THE BIENNIAL
13 PERIOD ENDING JUNE 30, 1993; AND FOR OTHER PURPOSES."

Subtitle

16 "AN ACT TO MAKE A SUPPLEMENTAL APPROPRIATION TO THE
17 DEPARTMENT OF FINANCE AND ADMINISTRATION - DIVISION OF
18 RACING."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. APPROPRIATIONS . There is hereby appropriated, to the
23 Department of Finance and Administration - Division of Racing, to be payable
24 from the State Central Services Fund, for personal services and operating
25 expenses of the Department of Finance and Administration - Division of Racing
26 which shall be supplemental and in addition to those funds appropriated in
27 Section 4 of Act 1117 of 1991, for the remainder of the biennial period ending
28 June 30, 1993 the following:

7 SECTION 2. Item (11) of Section 2 of Act 1117 of 1991 is hereby amended
8 to read as follows:

9 "(11) GENERAL VET. ASSISTANT 1 \$ 75 166"

11 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
12 authorized by this Act shall be limited to the appropriation for such agency
13 and funds made available by law for the support of such appropriations; and
14 the restrictions of the State Purchasing Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal control
17 laws of this State, where applicable, and regulations promulgated by the
18 Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.
20

21 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
22 Assembly that any funds disbursed under the authority of the appropriations
23 contained in this Act shall be in compliance with the stated reasons for which
24 this Act was adopted, as evidenced by the Agency Requests, Executive
25 Recommendations and Legislative Recommendations contained in the budget
26 manuals prepared by the Department of Finance and Administration, letters, or
27 summarized oral testimony in the official minutes of the Arkansas Legislative
28 Council or Joint Budget Committee which relate to its passage and adoption.
29

30 SECTION 5. CODE. All provisions of this Act of a general and permanent
31 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
32 Code Revision Commission shall incorporate the same in the Code.
33

34 SECTION 6. SEVERABILITY. If any provision of this Act or the
35 application thereof to any person or circumstance is held invalid, such

1 invalidity shall not affect other provisions or applications of the Act which
2 can be given effect without the invalid provision or application, and to this
3 end the provisions of this Act are declared to be severable.

4

5 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
6 with this Act are hereby repealed.

7

8 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
9 Seventy-Ninth General Assembly meeting in Regular Session, that funds provided
10 by the Seventy-Eight General Assembly for the operation of the Department of
11 Finance and Administration - Division of Racing may be insufficient due to
12 unforeseen circumstances, for the Department of Finance and Administration -
13 Division of Racing to continue to provide essential government services; that
14 the provisions of this Act will provide the necessary monies for the
15 Department of Finance and Administration - Division of Racing to continue to
16 provide such services; and that a delay in the effective date of this Act
17 could work irreparable harm upon the proper administration of essential
18 government programs. Therefore an emergency is hereby declared to exist and
19 this Act being necessary for the immediate preservation of the public peace,
20 health and safety shall be in full force and effect from and after the date of
21 its passage and approval.
