For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF FINANCE AND
10 ADMINISTRATION - DIVISION OF RACING WHICH SHALL BE
11 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS WHICH MAY BE
12 APPROPRIATED BY THE 79TH GENERAL ASSEMBLY, FOR THE
13 BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR OTHER
14 PURPOSES."

17 "AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION -
18 DIVISION OF RACING SUPPLEMENTAL APPROPRIATION."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
23 Department of Finance and Administration - Division of Racing, to be payable
24 from the State Central Services Fund, for personal services and operating
25 expenses of the Department of Finance and Administration - Division of Racing
26 which shall be supplemental and in addition to such funds as may be
27 appropriated by the Seventy-Ninth General Assembly, for the biennial period
28 ending June 30, 1995 the following:

6 SECTION 2. EXTRA HELP - HORSE RACING. There is hereby authorized, for

7 the Department of Finance and Administration - Division of Racing - Horse

8 Racing, for the 1993-95 biennium, the following maximum number of part-time or

9 temporary employees, to be known as "Extra Help", payable from funds

10 appropriated herein for such purposes and on a daily basis:

15 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

16 authorized by this Act shall be limited to the appropriation for such agency

17 and funds made available by law for the support of such appropriations; and

18 the restrictions of the State Purchasing Law, the General Accounting and

19 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

20 Procedures and Restrictions Act, or their successors, and other fiscal control

21 laws of this State, where applicable, and regulations promulgated by the

22 Department of Finance and Administration, as authorized by law, shall be

23 strictly complied with in disbursement of said funds.

25 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General

26 Assembly that any funds disbursed under the authority of the appropriations

27 contained in this Act shall be in compliance with the stated reasons for which

28 this Act was adopted, as evidenced by the Agency Requests, Executive

29 Recommendations and Legislative Recommendations contained in the budget

30 manuals prepared by the Department of Finance and Administration, letters, or

31 summarized oral testimony in the official minutes of the Arkansas Legislative

32 Council or Joint Budget Committee which relate to its passage and adoption.

33

34 SECTION 5. CODE. All provisions of this Act of a general and permanent

35 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

1 Code Revision Commission shall incorporate the same in the Code.

2

3 SECTION 6. SEVERABILITY. If any provision of this Act or the
4 application thereof to any person or circumstance is held invalid, such
5 invalidity shall not affect other provisions or applications of the Act which
6 can be given effect without the invalid provision or application, and to this
7 end the provisions of this Act are declared to be severable.

8

9 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
10 with this Act are hereby repealed.

11

12 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
13 Seventy-Ninth General Assembly meeting in Regular Session, that funds that may
14 be provided by the Seventy-Ninth General Assembly for the operation of the
15 Department of Finance and Administration - Division of Racing may be
16 insufficient due to unforeseen circumstances for the Department of Finance and
17 Administration - Division of Racing to continue to provide essential
18 government services; that the provisions of this Act will provide the
19 necessary monies for the Department of Finance and Administration - Division
20 of Racing to continue to provide such services, and that a delay in the
21 effective date of this Act could work irreparable harm upon the proper
22 administration and provision of essential governmental programs. Therefore,
23 an emergency is hereby declared to exist and this Act being necessary for the
24 immediate preservation of the public peace, health and safety shall be in full
25 force and effect from and after July 1, 1993.
