18	SECTION 1. (a) There is created the Task Force on Rails to Trails
19	Conservancy.
20	(b) The Task Force shall be composed of ten (10) members to be selected
21	as follows:
22	(1) one (1) member of the State Parks, Recreation and Travel
	Commission to be appointed by the Chairman of the Commission;
24	(2) one (1) member of the Arkansas Nature Conservancy to be
	appointed by the Chairman of the Arkansas Nature Conservancy;
26	(3) one (1) member of the State Highway Commission to be appointed
	by the chairman of the commission;
28	(4) two (2) members of the House of Representatives to be
29	appointed by the Speaker of the House;
30	(5) two (2) members of the Senate to be appointed by the President
	Pro Tempore of the Senate; and (6) three (2) members to be appointed by the Covernor
32	(6) three (3) members to be appointed by the Governor.
33	(c) The members of the Task Force shall select a chairman.(d) The members of the Task Force shall serve without compensation.
35	(e) Staff support for the Task Force shall be provided by the Arkansas

         SECTION 2. The Task Force on Rails to Trails Conservancy shall
 4 investigate the possibility of establishing a Rails to Trails Conservancy in
 5 Arkansas. The Task Force shall report its findings to the Governor and the
 6 Arkansas General Assembly by January 1, 1995.

         SECTION 3. The Task Force on Rails to Trails Conservancy shall expire
 9 on January 1, 1995.

         SECTION 4. All provisions of this act of a general and permanent nature
12 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
13 Revision Commission shall incorporate the same in the Code.

         SECTION 5. If any provision of this act or the application thereof to
16 any person or circumstance is held invalid, such invalidity shall not affect
17 other provisions or applications of the act which can be given effect without
18 the invalid provision or application, and to this end the provisions of this
19 act are declared to be severable.
