ACT 85 OF 1993
HOUSE BILL 1218

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF EDUCATION -
10 ARKANSAS STATE LIBRARY FOR THE BIENNIAL PERIOD ENDING JUNE
11 30, 1995; AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE DEPARTMENT OF EDUCATION - ARKANSAS STATE
15 LIBRARY APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. REGULAR SALARIES. There is hereby established for the
20 Department of Education - Arkansas State Library for the 1993-95 biennium, the
21 following maximum number of regular employees whose salaries shall be governed
22 by the provisions of the Uniform Classification and Compensation Act (Arkansas
23 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
24 Provided, however, that any position to which a specific maximum annual salary
25 is set out herein in dollars, shall be exempt from the provisions of said
26 Uniform Classification and Compensation Act. All persons occupying positions
27 authorized herein are hereby governed by the provisions of the Regular
28 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
29 successor.

23 SECTION 2. EXTRA HELP - STATE. There is hereby authorized, for the

24 Department of Education - Arkansas State Library - State for the 1993-95

25 biennium, the following maximum number of part-time or temporary employees, to

26 be known as "Extra Help", payable from funds appropriated herein for such

27 purposes: Seven (7) temporary or part-time employees, when needed, at rates

28 of pay not to exceed those provided in the Uniform Classification and

29 Compensation Act, or its successor, or this act for the appropriate

30 classification.

32 SECTION 3. APPROPRIATIONS - STATE. There is hereby appropriated, to the

33 Department of Education - Arkansas State Library, to be payable from the State

34 Library Fund Account, for personal services and operating expenses of the

35 Department of Education - Arkansas State Library for the biennial period

18 SECTION 4. EXTRA HELP - FEDERAL. There is hereby authorized, for

19 the Department of Education - Arkansas State Library - Federal for the 1993-95

20 biennium, the following maximum number of part-time or temporary employees, to

21 be known as "Extra Help", payable from funds appropriated herein for such

22 purposes: Five (5) temporary or part-time employees, when needed, at rates of

23 pay not to exceed those provided in the Uniform Classification and

24 Compensation Act, or its successor, or this act for the appropriate

25 classification.

27 SECTION 5. APPROPRIATIONS - FEDERAL. There is hereby appropriated, to

28 the Department of Education - Arkansas State Library, to be payable from the

29 federal funds as designated by the Chief Fiscal Officer of the State, for

30 personal services and operating expenses of the Department of Education -

31 Arkansas State Library for the biennial period ending June 30, 1995, the

32 following:

14 SECTION 6. APPROPRIATIONS - REVOLVING. There is hereby appropriated, to
15 the Department of Education - Arkansas State Library, to be payable from the
16 State Library Revolving Fund, for operating expenses of the Department of
17 Education - Arkansas State Library for the biennial period ending June 30,

31 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
32 authorized by this Act shall be limited to the appropriation for such agency
33 and funds made available by law for the support of such appropriations; and
34 the restrictions of the State Purchasing Law, the General Accounting and
35 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1 Procedures and Restrictions Act, or their successors, and other fiscal control
2 laws of this State, where applicable, and regulations promulgated by the
3 Department of Finance and Administration, as authorized by law, shall be
4 strictly complied with in disbursement of said funds.

5

6 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General
7 Assembly that any funds disbursed under the authority of the appropriations
8 contained in this Act shall be in compliance with the stated reasons for which
9 this Act was adopted, as evidenced by the Agency Requests, Executive
10 Recommendations and Legislative Recommendations contained in the budget
11 manuals prepared by the Department of Finance and Administration, letters, or
12 summarized oral testimony in the official minutes of the Arkansas Legislative
13 Council or Joint Budget Committee which relate to its passage and adoption.

14

15 SECTION 9. CODE. All provisions of this Act of a general and permanent
16 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
17 Code Revision Commission shall incorporate the same in the Code.

18

19 SECTION 10. SEVERABILITY. If any provision of this Act or the
20 application thereof to any person or circumstance is held invalid, such
21 invalidity shall not affect other provisions or applications of the Act which
22 can be given effect without the invalid provision or application, and to this
23 end the provisions of this Act are declared to be severable.

24

25 SECTION 11. GENERAL REPEALER. All laws and parts of laws in conflict
26 with this Act are hereby repealed.

27

28 SECTION 12. EMERGENCY CLAUSE. It is hereby found and determined by the
29 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas
30 prohibits the appropriation of funds for more than a two (2) year period; that
31 the effectiveness of this Act on July 1, 1993 is essential to the operation of
32 the agency for which the appropriations in this Act are provided, and that in
33 the event of an extension of the Regular Session, the delay in the effective
34 date of this Act beyond July 1, 1993 could work irreparable harm upon the
35 proper administration and provision of essential governmental programs.

1 Therefore, an emergency is hereby declared to exist and this Act being
2 necessary for the immediate preservation of the public peace, health and
3 safety shall be in full force and effect from and after July 1, 1993.
