Any county quorum court may designate all or any portion of 19 20 any undedicated county sales and/or use tax to be used for capital 21 improvements to and/or the maintenance and operation of any technical college. 22 23 SECTION 2. In the alternative the quorum court may refer to a vote of 24 the people at any general or special election the issue of dedicating all or a 25 portion of any undedicated county sales and/or use tax to any technical 26 college to be used for capital improvements to and/or the maintenance and 27 operation of the technical college. If the voters dedicate all or a portion 28 of the tax, it shall remain so dedicated until the voters decide otherwise. 29 3 0 SECTION 3. When the quorum court calls an election on the issue of the 31 levy of any county sales and/or use tax, it may also cause to be placed on the 32 ballot the issue of dedicating all or a portion of the tax for capital 33 improvements to and/or the maintenance and operation of any technical college. 34 SECTION 4. If a technical college for which a tax is dedicated or 35 36 levied hereunder thereafter becomes a branch of an existing institution of

1 higher education, the tax dedicated or levied hereunder shall continue to be
 2 dedicated and levied for the use and benefit of the branch unless reduced or
 3 repealed as authorized hereunder.

         SECTION 5. All provisions of this act of a general and permanent nature
 6 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 7 Revision Commission shall incorporate the same in the Code.

         SECTION 6. If any provision of this act or the application thereof to
 9
10 any person or circumstance is held invalid, such invalidity shall not affect
11 other provisions or applications of the act which can be given effect without
12 the invalid provision or application, and to this end the provisions of this
13 act are declared to be severable.
