Arkansas Code 17-82-104(b) is amended to read as follows: 18 "(b) (1) It is unlawful for any corporation to practice dentistry or 19 dental hygiene or to hold itself out as entitled to engage therein. 20 21 (2) A registered licensed dental hygienist working at an Arkansas 22 Department of Correction facility may work under the general supervision of a 23 licensed dentist. General supervision as used in this section means that: (A) The dentist shall establish a written office protocol which 24 25 specifically indicates when a hygienist may treat a patient and when a patient 26 is to be seen by a dentist; (B) The hygienist shall specifically adhere to the protocol for 27 28 treatment developed by the dentist; (C) General supervision is limited to prophylaxis, application of 29 30 sealants, root planning and any duties normally assigned to dental assistants; (D) The dentist is to review and countersign all entries made in 31 32 the patient s chart by the hygienists within seven (7) working days; 33 (E) All hygienists working in a general supervision capacity 34 shall be currently certified in CPR; (F) The hygienist shall review dental health history prior to 35 36 treatment."

1 2 SECTION 2. All provisions of this act of a general and permanent nature 3 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 4 Revision Commission shall incorporate the same in the Code. 5 6 SECTION 3. If any provision of this act or the application thereof to 7 any person or circumstance is held invalid, such invalidity shall not affect 8 other provisions or applications of the act which can be given effect without 9 the invalid provision or application, and to this end the provisions of this 10 act are declared to be severable. 11 SECTION 4. All laws and parts of laws in conflict with this act are 12 13 hereby repealed. 14 15 SECTION 5. EMERGENCY. It is hereby found and determined by the General 16 Assembly that there is urgent need to authorize dental hygienists to work 17 under general supervision of a licensed dentist in certain settings; that this 18 act is designed to permit such practice under strict guidelines and should be 19 given effect immediately. Therefore, an emergency is hereby declared to exist 20 and this act being necessary for the preservation of the public peace, health 21 and safety shall be in full force and effect from and after its passage and 22 approval. 23 /s/B.G.
