14	"AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION -
15	DISBURSING OFFICER APPROPRIATION."

17	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18	
19	SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
20	Department of Finance and Administration - Disbursing Officer, to be payable
21	from the State General Services Fund Account, for grants to the Arkansas
22	Artists' Registry, the sum of \$25,000 each fiscal year of the biennial
23	period ending June 30, 1995.
24	
25	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
26	authorized by this Act shall be limited to the appropriation for such agency
27	and funds made available by law for the support of such appropriations; and
28	the restrictions of the State Purchasing Law, the General Accounting and
29	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
30	Procedures and Restrictions Act, or their successors, and other fiscal contro
31	laws of this State, where applicable, and regulations promulgated by the
32	Department of Finance and Administration, as authorized by law, shall be
33	strictly complied with in disbursement of said funds.
34	
35	SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
36	Assembly that any funds disbursed under the authority of the appropriations

1 contained in this Act shall be in compliance with the stated reasons for which 2 this Act was adopted, as evidenced by the Agency Requests, Executive 3 Recommendations and Legislative Recommendations contained in the budget 4 manuals prepared by the Department of Finance and Administration, letters, or 5 summarized oral testimony in the official minutes of the Arkansas Legislative 6 Council or Joint Budget Committee which relate to its passage and adoption. 7 SECTION 4. CODE. All provisions of this Act of a general and permanent 9 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 10 Code Revision Commission shall incorporate the same in the Code. 11 SEVERABILITY. If any provision of this Act or the 12 SECTION 5. 13 application thereof to any person or circumstance is held invalid, such 14 invalidity shall not affect other provisions or applications of the Act which 15 can be given effect without the invalid provision or application, and to this 16 end the provisions of this Act are declared to be severable. 17 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict 18 19 with this Act are hereby repealed. 20 21 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the 22 Seventy-Ninth General Assembly, that the Constitution of the State of Arkansas 23 prohibits the appropriation of funds for more than a two (2) year period; that 24 the effectiveness of this Act on July 1, 1993 is essential to the operation of 25 the agency for which the appropriations in this Act are provided, and that in 26 the event of an extension of the Regular Session, the delay in the effective 27 date of this Act beyond July 1, 1993 could work irreparable harm upon the 28 proper administration and provision of essential governmental programs. 29 Therefore, an emergency is hereby declared to exist and this Act being 30 necessary for the immediate preservation of the public peace, health and 31 safety shall be in full force and effect from and after July 1, 1993. /s/John E.
